The Estacada High School football season will begin on Friday afternoon, October 5th, when the home eleven will tangle with their old rivals from the county seat, on the Estacada grounds.

A big crowd of local rooters should be on hand, for this battle will be a royal one, commencing where the 1915 season left off, when Oregon City and Estacada played a tie game until darkness stopped the contest.

It is unusual for the local team to begin its season with such a hard antagonist, but O.C.H.S. will be in the same condition and as a return game is to be played November 30th in Oregon City, the question of county supremacy will remain until snow falls.

Under the direction of Coach Rutherford, who is heralded as a football wizard, having learned the game under Bezdeck, the home team is already in good fighting shape, despite the loss of a number of the varsity men of last year, who either graduated or have enlisted.

In accordance with the schedule published in the Bulletin the first session of the Student Body organization was held the first Friday afternoon of the school month. Parliamentary drill and good natured fun at the expense of the Freshmen was indulged in. The Freshmen showed ability to come back and with their numbers equal to about half the entire student body the upper classmen will not have the edge on them.

The second Friday afternoon, was given over to the Adelpheid Literary Society. A short program was given consisting of musical and literary numbers.

Following the literary program Friday, in one of the snappiest games played for years, the Websterian Literary Society defeated the Adelpheids 7 to 6. This game was the annual contest and settles the affair for this football season.

More Local Boys Enlist

The third call from Clackamas County for more recruits, under the provisions of the Conscription Act, this week resulted in the enlistment from this community of Harry C. Reid of Garfield, Dr. William M. Dale of Estacada and Ennis Townsend of Bull Run, formerly of Estacada.

The boys reported at Oregon City on Thursday the 4th, expecting to leave Friday morning for American Lake.

Dr. Dale hopes later to receive an appointment in the Dental Corps, where his services as a dentist are needed. Harry Reid was named as first alternate and expects to be enlisted, as it is not likely all of the twenty-one in this call will respond.

War Library Fund

Nearly Doubles Quota

As usual, Eastern Clackamas County came to the front in response to the raising of funds for the War Library Fund, with its quota of \$25 surpassed by \$20.77, making a total contribution of \$45.77.

Credit for this response is largely due Mrs. A. W. Botkin of Garfield, chairman of the local committee and the ladies who aided her in the work.

In the George district alone \$10 was subscribed, with \$5 coming from the George S. & C. Club.

Garfield Road District Absorbed

At the meeting of the county court last week, action was taken doing away with Road District No. 10 in Garfield, dividing that district between districts 49 and 9, being Upper Garfield and George, respectively.

This was the only district in the county to be absorbed and the court's action was a surprise to 99% of the tax payers, none of whom expected such a move or seem to know who asked for such consolidation.

The new arrangement extends the George district along the section line near the Tracy School to the Currinsville district line; with the balance of district 10 taken into the Upper Garfield district.

No one seems to be able to explain the court's action in this instance, as it has been proven that the larger the districts, the harder it is to have special road taxes voted.

At present, few can see where much benefit will come from this new arrangement, although the court probably had good reasons for its actions.
