During the discussion of the various appropriations at the late County Budget Meeting, considerable criticism was aimed at the heavy expense of the Justice Courts, amounting to \$2,000.

Investigation shows that this department is not self-supporting from fines and costs, but a decided economy can be effected, if such saving is really desired.

It has been the custom in too many cases in the Estacada Court and probably is in other outlying justice courts, for the district attorney or his assistant to take the cases before the Justice of the Peace at Oregon City, instead of having them tried in the locality in which they originate.

This proceedure means a heavy added expense in costs and time, for milage for witnesses etc. when if the district attorney or his assistant would travel to the outlying courts, it would merely mean the expense and mileage of the officer, instead of all parties interested in the case.

Let's see District Attorney Hedges or Tom Burke appear before the outlying courts, instead of insisting that the case and the parties thereto be brought before them.

The week of February 4th has been designated for the registraof the half million or more unnaturalized Germans in this country, with the work handled by the police departments and postmasters.


Registration will involve the gathering of detailed information concerning the business, relatives and habits of every German, together with photographs and


