Full information as to the details of this registration and the furnishing of photographs may be obtained from the postmaster. Failure to comply with this proclamation will be severly punished by the authorities.

In the case of the ordinances emanating from the City Council, the law allowed a choice of either hiding them from public gaze on a few telephone poles or publishing in the newspaper, with the former method usually adopted. but in the instance of the annual school meeting the law prescribed the proceedure and the puolisher modestly and bashfully asserted his rights.
