IN REGARD TO THE WATER IMBROGLIO

A suit has been instituted by the city of Estacada, in the circuit court against Mrs. F. L. Heylman for \$334 back water rent. By referring to the report of the March meeting of the council, it will be seen that a bill of \$300 was presented to that body by Mrs. Heylman, for right of easement for water main which passes through her property. This bill the council rejected. It is not our intention to comment, because the case if not settled amicably, will be tried in the court. This tangle with a number of other long outstanding accumulations of water rent arrears, the present council has inherited.

The late recorder was grossly negligent, to put it mildly, in collecting the water rents, and in keeping accounts, which finally caused such a muddle, that he did not know, nor could an expert accountant ascertain, what was due to the city. There was an evident shortage, which finally was compromised by the acceptance of a thousand dollars tender-

ed by his wife.

A number of citizens are owing various sums, which aggregate a large amount. The present council is endeavoring to collect these, as it is their bounden duty, and the city needs the money imperatively. Some have paid, others are paying by installments, and others are ignoring the demand. Yet these are valid debts, the same as store bills. It may well be asked why previous councils allowed such a condition to continue? It may be, that they can be called to account for such negligence, which places the present council in a most unenviable position, either to violate their oath of office or risk offending their personal friends.

Mayor Bartlett has been criticized for pressing the case against the late recorder and endeavoring to collect the back rents, but he has been only doing his duty, which if his predecessors had done, it would not have devolved on him.
