My dear Mr. Hawley;

Referring to your letter of the 11th inst, relative to the opening of the remaining agricultural lands in the Coos Bay and O. and C. railroad grants, would say that I canvassed this situation pretty thoroughly when I was in the West recently, and it seemed to be the consensus of opinion, in which I concurred, that if we should start to open these lands at the present time, it would bring the filing and entry time right about the middle of the winter which would be inadvisable, and that we had best get out our maps and data early, say by the latter part of December or early in January, with a view to the opening in the early spring, and this is our present plan.
