## MRS. W. J. MOORE LAID TO REST

Tuesday morning at 4:30 Mrs. W. J. Moore quietly passed away. As she had been in a state of coma for some time, the end had been momentarily expected by her friends.

Anna Edna Reid was born June 3, 1865, at Smith's Falls, Ontario, Canada, where in 1891 she was married to W. J. Moore. Eight years later Mr. and Mrs. Moore left Canada for Alaska, where they remained about four years, Mr. Moore at first mining and later working for the government. In 1903 they came to the states settling at Seattle, and in 1905 to Estacada where they have lived ever since. About six years ago Mrs. Moore was afflicted with heart trouble and her health began to fail. Although everything was done to relieve her, and both husband and son devoted themselves entirely to her, she did not improve. A year ago she suffered from a stroke of paralysis, the effects of which she never got over, although she recovered sufficiently to get out and walk around. But it was sadly evident that she was failing in mind and body. About two weeks before her demise, she had a relapse and lost consciousness in which condition she remained until released by death.

She will be greatly missed by those who knew her, especially in former years before she began to break down. Besides her husband she leaves one son, Burton and her daughter-in-law, his wife. The funeral was held in the Methodist church yesterday afternoon at 2:30, and was largely attended. The service was conducted by the Rev. A. Demoy, an old friend, who spoke beautiful and consoling words. Some of her favorite hymns and a special piece, "In the Land of the Setting Sun" were sung. The interment took place in Lone Oak cemetery under the directions of R. R. Carlson of Gresham.

As her other immediate relatives live in Canada, none were able to be present, but some friends from Portland attended. These were A. H. Richmond and daughter Miss Nell, who are the father and sister of Mrs. Burt Moore. Mrs. C. G. Cathcart and A. F. Benson.

## Salvation Army Notes

The Oregon budget has been increased to include the purchase of the property to be made into a Salvation Army Industrial and Agricultural school for boys. The first budget of \$244,000 which contemplated the extension of the Salvation Army Home Service program to the remote districts of the state, was declared insufficient to handle the big program outlined by the state board after a study of the county board confidential reports. The quota for Clackamas county amounts to \$7,810.

## Revival Meetings

Revival services will be held at the Eagle Creek Church every night this week and next. They will be conducted by the Rev. J. D. and Mrs. McLennan, assisted by the cowboy preacher, the Rev. S. G. Bettes. Everybody is invited.

Multnomah County Pomona Grange, at a recent all-day session, not only endorsed the relief bill for higher education in Oregon, but requested its nine subordinate Granges to go out in their communities and work for the bill. The Oregon Dairy Council has also strongly endorsed the bill, which is to be voted upon May 21, and which provides 1.26 mills to protect the work of the Agricultural College, the State University and the Normal School.

Monday, April 5, is the last day for paying taxes without penalty.
