FRUIT GROWERS ORGANIZE THEMSELVES

The organization meeting of the Oregon Fruit Growers Association, met at the Family Theatre Saturday afternoon and was attended by about thirty five fruit growers.

The meeting was called to order by Mr. Evans of the association. After relating the plans of the association, ballot was taken for two more members for the local committee, Mr. Jacques remaining on the committee as chairman, H. D. Trapp representing the Upper Garfield district and Wm. Tucker representing Springwater, were elected.

Mr. Seymore Jones, former speaker of the house, outlined the financial side of the association's work and gave his experience as a fruit seller, showing the value of a state wide organization. He said that the amount of dollars lost to the fruit growers this past season through selling by individuals at lower than the market rates, would finance the association.

During the past week nine new members representing a hundred acres of land, signed up for membership, bringing the total in this district to thirty-three with 348 acres of fruit.

It was stated that Mr. Holt would be in the city in the near future to arrange for a receiving station.
