#### The American Legion will Organize Auxiliary

Monday evening, May 3rd, at the I. O. O. F. hall the Women's Auxiliary of the Carl Douglasa Post, No. 74, American Legion of Oregon, will be organized. All persons eligible for me.nbership are cordially invited to be present. Membership in the auxiliary will be limited to the mothers, wives, daughters and sisters of the members of the American Legion, and to the mothers, wives, daughters and sisters of all men and women who were in the military or naval service of the U.S. between April 6, 1917 and November 11, 1918, and died in the line of duty or after honorable discharge and prior to November 11, 1920.

The question "what are the women who have been doing war work going to do, now the war is over?" has often been heard. The answer to this question as found by millions of women, is set forth in the preamble of the national constitution of the American Legion printed on the reverse side of every membership card of the Women's Auxiliary, which says: "For God and country we associate ourselves together for the following purposes: To uphold and defend the constitution of the U.S. of America: to maintain law and order; to foster and perpetuate a one hundred per cent American ism: to preserve the memories and incidents of our associotion in the Great War; to inculcate a sense of individual obligation to the community, state and nation; to combat the autocracy of both the classes and the masses; to make right the master of right; to promote peace and good will on earth; to safe guard and transmit to posterity the principles of justice, freedom and democracy; to consecrate and sanctify our comradeship by our devotion to mutual helpfulness.',

Remember the date, May 3rd, and don't forget to be present. The American Legion and its Women's Auxiliary will go down in history as the G. A. R. and its Auxiliary. Relatives of

members of other posts may join our auxiliary. Let us get together one hundred per cent. Refreshments will be served.

He has been county traffic officer and deputy sheriff for the last three years and resigned last week simultaneously with making the announcement of his candidacy. During the paper mill strike, Meads was placed in charge of the state police, and during the war he was put on duty to check up slackers and deserters. He has been a terror to automobile thieves and speed maniacs. His most recent activities have been in connection with moonshiners and bootlegging violations. He was forentan on construction for the Willamette Valley Southern railway six years ago. Meads announces his intention of making a vigorous campaign. - Oregon City Enterprise, Apr. 17.

## SHUEBEL ET AL ADDRESS MEETING

Last Friday night a bunch of politicals headed by Chris Schuebel drove over from Oregon City to enlighten our citizens on the cause of taxes being so high.

Mr. Schuebel has made a study of the problem and thinks he has solved it. The reason for high taxes is that one third of the value of taxable property is escaping taxation. F. D. Shank of Damascus, who is running for representative spoke on his candidacy, improved highways and good legislation. E. W. Bartlett then made a forcible and eloquent speech for the higher educational tax measures. The meeting was held in the Family Theatre.
