

Thanks are due our kind neighbor P. M. Wagner for a mess of fine trout, which proved delicious to the taste and helped out the high cost of living.


Mrs. James Norris of Dwyer,s camp was in town Monday.

The General Fund Bill which saves the State about \$10,000 annually in payment of interest.

The repeal of \$1,000,000 standing appropriations.

State Board of Conciliation and Arbitration law.

The Foreign Corporation License Fee law, which adds about \$85,000 to the general fund annually.

Amendment to the Inheritance tax law which adds \$435,000 to the general fund annually.

- The law that will assess corporations at the same rate as farmers and small property owners. This will add about \$10,000,000 to the assessed valuation of Clackamas County.

Equalizing fees of domestic corporations, which will compel large corporations to pay at the same rate as small corporations. Will add approximately \$100,000 to the general fund annually.

State Highway commission to purchase all road material and to sell to counties at cost. Buying in large quantities will save thousands of dollars on road material.
