LIMITATION OF FOUR PER CEMT STATE INDEPTEDNESS FOR PERMANENT ROADS.—Purpose: To amend Section 7 of Article XI of the Constitution of the State of Oregon so as to permit the creation of debts and liabilities including previous debts and liabilities for the purpose of building and maintaining permanent roads to the amount of four per cent of the assected valuation of all the property in the State of Oregon, instead of two percentas new provided by law.
