THE HUMAN MAKEUP

"The proper study of mankind is man," and it is a most absorbingly interesting one. The old philosopher's maxim, "know thyself," is preeminently wise and appeals to every thoughtful man. This study covers a wide range but it begins with the constitution or makeup of himself. The first thing about himself a man discovers, in order of experience, is that he has a body. The sensations of an infant are nearly all bodily ones. He is hungry, tired, or a pin pricks him, and he makes his discomfort known by the only way he can, the use of his lungs. Later on his mental faculties come into play, and still later spiritual ones. But it will be some years before he draws any such distinctions for himself, or regards them as indications of the composite character of his being.

But these indicate clearly that he has three groups or sets of faculties: Bodily—passive and active; psychical—intellect, feeling and will; spiritual—conscience, spiritual insight, religious aspiration, and moral choice. There are two schools among students which differ as to the number of substantial parts of man's nature, whether these are two or three; whether he is to be considered as made up of body, soul and spirit or as body and soul; spirit and soul being considered identical in substance though differing in function. The question in practice is unimportant, for both schools admit that these parts are organically related, and that all the three-fold functions and faculties of man's nature are likewise organically related and mutually conditioned so that the whole living man is affected by and acts in each.

In this and subsequent articles the writer adopts the position that man is made up of body, soul and spirit. The soul is the psyche of the Greek, comprising intellect, feeling and will, while the spirit is the pneuma through which moral and religious principles are discerned and apprehended.

The study is most important for thereby is disclosed the purpose or end in life men are intended to serve and their final destiny foreshown. A man who has given it only the slightest attention or thought will agree with the psalmist, "I am fearfully and wonderfully made."

oil leases. It is surprising how crime will uncover itself in spite of the most elaborate and ingenious precautions to prevent it. Every experienced detective can tell numbers of interesting stories to this effect. Of course some crimes are never solved, but the great majority sooner or later will be, and their perpetrators punished. There seem to be moral forces working against the criminal, to insure that "his mischief shall return upon his own head, and his violent dealing shall come down upon his own pate."

SECY DENBY'S DEFENSE

The secretary of the navy declares he will not resign under fire, and justifies his action in the matter of the oil leases. He declares: "When I came into office I was very shortly convinced that the oil reserve lands which had been set aside by Congress for the benefit of the United States navy were being drained by private owned wells adjoining these reserves. My conviction that these oils were being drained was based upon a number of reports and statements by those who know Governmental and other experts. That they were being drained is undisputed."

"Congress, under date of June 4, 1920, gave the following powers to the secretary of the navy: 'That the secretary of the navy is directed to take possession of all properties within the naval petroleum reserves as are or may become subject to the control and use by the United States for naval purposes. * * * To conserve, develop, use and operate the same in his discretion, directly or by contract, lease or otherwise, and to use, store, exchange or sell the oil and gas products thereof, and those from all royalty oil from lands in the naval reserves, for the benefit of the United States.'"

He probably acted honestly but Fall's action was different.

STATE INCOME TAX

E. Hofer & Sons, publishers of the Manufacturer and Industrial Bureau of Salem, have sent a circular letter to the editors of the state for their opinion of the state income tax. They cite instances of two prominent men who maintained large payrolls who moved out of the state to avoid this tax. They claim they have received reports of a number of others who contemplate this step. The Ford Motor Assembling plant in Portland which had planned to enlarge is, so it is reported, to be removed. When the tax was proposed we opposed it, as it would drive capital out of the state, and the above instances prove our supposition was correct.

In computing his federal income tax the farmer may deduct all amounts paid in producing, harvesting and marketing of crops, including labor, cost of seed and fertilizer used, cost of minor repairs to farm buildings (other than the dwelling), cost of repairs to fences and machinery and the cost of small tools used up in the course of the year, such as pitchforks hand rakes, hoes, axes, etc.
