**PARENTAL LAXITY**  
 If any evidence was wanting or any more convincing of the criminal lack on the part of parents to rear their children in a proper manner, the recent occasion of Halloween furnished such an abundance of it that it is impossible to overlook it without mention. Mothers of little girls from 5 to 10 years of age were so neglectful of their duty that they allowed them to prowl the streets until late hours and mingle with the crowd of older ones engaged in all sorts of depredations wherein the rights of others were totally ignored, to listen to every sort of vile language, to witness many lawless acts committed by older ones, and in a general way see and hear many things that their tender years should deny them. Boys, also, through the fault of both parents, sally forth bent upon all sorts of deviltry that youth can think of, and if they are home and in bed by midnight their parents do not know of it and seemingly care. These, with those of ages ranging all through the teens, constitute a mob that is a disgrace to the bringing up of any youngster and a sad example of the household that turns them out. No one would deny to youth all the pleasure they can get out of life, but why once a year they are allowed to have unbridled license to commit all sorts of acts that would shame a Hottentot and cause a coolie Chinaman to think they were the offspring of the lowest savages is beyond the power of imagination of those people who are made to suffer by what is no fault of the youngster. If they were properly directed by their parents, and indulged only in harmless pranks, no word of censure would be heard, but when they wantonly destroy property, deface buildings, commit many other acts that would on any other occasion hail the parents into court to answer for them, we say it is time to call a halt and lay the blame for the condition where it belongs—upon the parent and argue the criminal responsibility be laid to them. Much at the present time is being said about the cause of crime and the tendency on the part of the young to follow after things of low degree. Is it any wonder, is it at all surprising, that they go wrong when the parents give no heed, as on this occasion, to what their boys and girls do, how much of a nuisance they are to others, and swim along in a "don't care a d—" attitude until their children have to be taken in charge to answer to the law? The fountainhead of all right doing is in the home. If it is polluted by criminal negligence there, God help the innocent child.

**THE TIME FOR HELP.**  
 Than Parent-Teacher associations there are few greater forces striving for the welfare of a state or a nation, says the Oregon Journal. They are an effective power in bringing together the school and the home for the sake of the child, to give him the good and spare him the bad. There was never greater need for such associations. In these days of jazz and delinquency, in these days when homes are wrecked and children left adrift, in these days when the average age of criminals is dropping toward the teens, it is time for the schools and the homes to be brought nearer together and for the factors for good to be combined. Seven of every ten children, it is stated, are growing up here without moral, ethical or religious training systematically given. But only 8 per cent of the schools of Oregon have parent-teacher organizations. Only 9 per cent of the school children have parents belonging to an organization. There are entire counties without an association. Why not an organization in every town and every city? Why not a close contact between the teachers and mothers of children in every community? Why not an organization that will keep children from the wrong paths, that will steel children morally, mentally and physically for the rigors of future life, and that will save them in the home and the school, rather than at the doors of the penitentiary? Children are not to be expected to save themselves. They do not teach themselves. They must be taught right from wrong. The way to save children is not by an appeal to the courts or pardoning power after a vicious crime is committed. It is by proper attention and direction before youth has entered crime. Parent Teachers' associations are proceeding in the direction of success. There should be more of them.

### HOME BREW RECIPE
