## Power Line Nearly Completed

MEMBERS OF CLACKAMAS ELECTRIC CO-OP. WILL RECEIVE POWER SOON

With only the installation of service entrances and meters remaining to be done members of the Clackamas Electric co-op will have electric power with in the next three weeks it was disclosed Monday at the annual meeting of that organization held at Sandy.

The Eagle Creek Canyon gap in the line was conquered last week when stretching of 1980 feet of 3-strand copper-weld cable was finished. The Portland General Electric company which will energize the system put in its connections on Tuesday.

### Directors Are Elected

At the annual meeting Monday the following were elected as directors of the co-op. Victor Bodley, C. H. Dice, Mildred R. Decker, Frances Hiatt, Roy Maxwell and C. J. Sandstrom all reelected and Leonard Anderson, C. H. Chaney and Chas. Updegrave.

### Serves Large Area

The northeast Clackamas project has just completed 61.9 miles of lines which serves Garfield, Porter, Firwood, George, Dover and the Sandy Ridge communities. There are 190 members in the Northeast Clackamas Electric Co-op.

### Merger Is Considered

The merger of the Northeast Clackamas Electric Co-op system with a second project designed to serve 200 or more rural homes in the Scotts Mills section is now being considered.

C. J. Sandstrom president of the power co-op reported at the meeting Monday that an REA official from Washington, D. C., was expected this week to survey the proposed expansion plan. He said that the Scotts Mills area already had organized and had upwards of 200 signed up as future customers.

### JURY DENIES DAMAGE CLAIM FOR \$16,000

The circuit court jury hearing the \$10,000 damage suit of Kate Kalman, administrator of the estate of M. J. Kalman, formerly of route 2, Boring against Arthur Milne doing business as the Milne Construction company the The Dalles and his driver Kenneth Cole deliberated about four hours Wednesday and returned a verdict in favor of the defendants.

This suit was the result of an automobile accident at the intersection of 82nd street and Dedman road on August 31, 1939 in which Kalman, 82, was fatally injured. The Milne truck was being driven by Cole and the Kalman machine collided.

Elsie Kalman, 17, and her brother Arthur, 13, filed damage suits some time ago against Milne and Cole. In this the jury also found for the defendants. Elsie asked \$3500 damages for injuries while Arthur sought to collect \$2500.

The jury in this case was composed of Albert Grosshong, as foreman, H. A. Hubbard, Allen Joy, Clarence Evans, Marguerite Milford, Edith Wallace, Geo. Blair, Marion Tong, W. J. Vick, Ethel Van Zante, Stanford Cox and Florence Jordan.

### FOREST ROADS ARE BEING CLOSED

The following roads in the Clackamas river ranger district in the Mt. Hood National forest are being closed for fall maintenance. Hillockburn road, Abbott road from North Fork crossing camp to High Rock, Shell Rock road, Peavine road, Clackamas river road from Oak Grove ranger station to Riverside camp and the Clackamas river road from the Three Links power plant to the Oak Grove ranger station.

Due to lack of surfacing on these roads it is necessary that they be closed each winter to protect them from wash and other damage.

Headquarters for the Clackamas river ranger district are now located at Estacada in the Masonic building.

### SELF DEFENSE STRESSED BY HIMLER COUNSEL

When George (Duke) Himler, 29, of Park Place ex-seaman and former carnival wrestler and boxer went on trial Tuesday morning in Clackamas county district court on a first degree murder charge involving the fatal knifing of Charles P. Straight, 56, of Clackamas Heights self defense was stressed by Himler's counsel. The trial began at 9:30 with Judge Earl C. Latourette presiding.

The case is being prosecuted by District Attorney Fred A. Miller assisted by his deputy Robert Mulvey, while Glenn R. Jack Oregon City attorney is representing Himler.

### Six Months Budget is Made

A tentative six months budget for Clackamas county has been prepared by the budget committee composed of members of the county court, Mrs. Edward E. Brodie, Jay Westcott and Irvin Lavier.

The half-year budget which will cover the period from January 1 to June 30, 1942 is necessitated by the new tax law which changes the fiscal year from the calendar year to the fiscal year of June 1-June 30. A new budget for the entire year will have to be drawn up June 30.

Highlights of the six months budget includes:

Twenty thousand dollars appropriated for a new agriculture-veterans' building to be located on some site in Oregon City, to house all agriculture offices, provide an auditorium, etc.

Five thousand dollars for new tax office equipment; this being recommended by the grand jury which asked for a change in the tax collecting setup.

Five thousand dollars for improvement of courthouse grounds, providing for an exit to the alley.

Three thousand dollars to air condition the county court room.

Several county employees were granted salary increases all elective officials receiving boosts by the last legislature.

In the sheriff's office \$750 was set for employment of a night patrolman, a new position and pay of the executive deputy, Geo. Jewell, and the night and day jailers was increased.

The only raise in the tax office went to chief deputy Gilbert Woodward who will receive \$150 instead of \$125 a month.

The first and second deputies in the clerks office were advanced from \$110 to \$125 a month, the other clerks to receive no increases under the budget.

A stenographer was added in the surveyor's office and the chief deputy's pay was advanced from \$150 to \$175 a month.

The county auditor, Donald Bauer, was given a raise from \$185 to \$200 a month and a stenographer also was added in this office.

The budget also disclosed that \$27,500 was placed in the general relief fund for the six month period, the appropriation for all of 1941 being \$50,000.

IRON IN SPRING WATER IS TROUBLESOME IN PIPES

Presence of dissolved iron in spring water causes considerable difficulty when such water is tepid to houses for domestic use according to reports repeatedly received by J. S. Jones agricultural chemist at Oregon state college. Sometimes this dissolved iron may come from the pipes themselves when the original water is strongly acid although more frequently it is dissolved out of the soil.

The only effective way of removing it from solution is by use of a tank or settling basin in which sodium carbonate is used to precipitate the iron after which it will settle out.

### Legion Aids in Navy Recruiting

According to announcement from David B. Simpson of Portland, state chairman of Navy Day on October 27 F. E. Dooley has been selected as chairman of the event in this locality.

In connection with the observance secretary of the navy Knox has been informed by Joseph K. Carson Jr. state commander of the American Legion that the Legion of this state will raise a company of 140 men for induction into the navy on that day. The induction ceremony is to take place in Portland at the civic auditorium and will be a part of a mass meeting and patriotic celebration dedicated to the navy. Shortly after the conclusion of the meeting the company of recruits will leave for San Diego to undergo their naval training period at the training station here.

Navy Day annually takes place on the birthday of former president Theodore Roosevelt who was instrumental in first adopting a sound basic naval policy for this country. In addition to paying a deserved tribute to the sea heroes of the nation and recalling the splendid part the navy has played in making and keeping us a dominant world power, the Navy Day observance has proved a valuable means of fostering a better understanding of the Navy and its work. Such information in a country where government is by public opinion is essential to the formulation of correct judgements affecting naval policy and in this work of dispensing information to the people of the United States, Navy Day has played a considerable part since its inauguration in 1922.

Mr. Dooley pointed out that by contacting a Legioneer or local recruiting officer eligible young men can make application for membership in the Legion's company and be assured of remaining among friends in the company for the duration of the training period which lasts 6 weeks. At the end of that time the men will be given the opportunity to qualify for advanced training in one of the navy's 58 trades. Among courses which will be offered to them are electricity, radio, signalling, machinist, and aviation machinist, metalsmith, boilermaker and many others. Mr. Dooley emphasized the fact that men are being accepted for the naval reserve which will allow them to return to their homes and jobs at the end of the national emergency.

He further stated that since considerable time is necessary for completing enlistment papers men interested in joining the Legion company should make applications at once.
