Local Option

We can only argue in favor of local option by making a comparison of prohibition with license territory. Take Kansas in 1881 with its population of 996,616 and 917 prisoners and now with its 1,470,495 population and only 788 prisoners and it shows an increase in population of nearly 50 per cent while crime has, comparing the number of inhabitants, decreased 65 per cent.

Five out of the 105 counties of Kansas where liquor is sold in violation of law and which have 17 per cent of the population of the state, furnish over 30 per cent of the crime of the state. This Local Option Bill, if it becomes a law does not make this a prohibition state but it is license still, and in the event that an election is had upon the question of prohibition in any county or subdivision thereof and fails to carry then the law remains as it now is, no more saloons only as established after a petition of two-thirds of the voters of a precinct have asked the county court to grant one.

Now it is only fair that this local option bill be supported by your vote. that if the majority of the voters of any precinct or county want no saloons they can legally have it so.
