The coupon contest for a trip to the World's Fair, is now on in earnest and henceforth instead of the holders of coupons reserving them to see who are to be candidates, they will begin voting them. If the coupons are handed out with each purchase it would take but three weeks at the outside to close the contest, which ends with the handing out of 60,000 coupons, 11,000 of which have been issued.
