THE announcement of Hon. S. B. Huston of Hillsboro, of his candidacy for congress will be well received by his many friends throughout the district. Mr. Huston is one of the foremost and able men in the district, and we believe he has every reason to feel confident of the nomination.

NOTWITHSTANDING the reports that other railroad influences are about to enter the field and establish an electric line between here and Portland, it is a fact nevertheless, that the Oregon Traction company, who have so persistently fought the combined forces of Portland railway companies, are building a line which will make this city its terminus—or a time at least. Of course if the other railroad people who have sought to discourage the Oregon Traction people, really intended to build, they could have done so long ago, but it was not their intention. As for this last flutter by the Consolidated, one is justified in taking it with a grain of doubt too.

THERE is a communication in another part of this paper asking some pertinent questions on matters pertaining to the method of conducting municipal affairs in this city. There can be no doubt that the stand against the present condition of our city's freedom in permitting saloons to do business, is well taken. It is true that there are three saloons open day and night in this city that do not pay one cent into the treasury, nor are they molested by anyone. In repealing all ordinances against or pertaining to the sale of intoxicating liquors here, the bars were let down and as a consequence the saloon men are getting rich, besides our condition and reputation are none the better for it. However, the repealing of the ordinances was made in order to give the ordinance granting licenses to sell liquor here full sway, and it was so framed as to cover every phase of the liquor question for which a majority of the voters contended, and for which the present council was elected, but no provision was or has been made to bridge over the intervening time between the decision of the Circuit court and that of the Supreme court. It is an evil and should be remedied.

THE consensus of opinion derived from the several interviews with prominent republicans of this city, made by The News, very plainly establishes the fact that the direct primary law should be given a fair trial. Any argument in favor of conventions for the purpose of recommending candidates to the voters, is looked upon with disfavor and is immediately branded as a scheme of the politicians to maintain their control. While some of the interviewed state that they did not vote for the direct primary law, when it was before the people a year ago, yet they believe it should have a fair trial, and then if found impractical, it should be repealed. The very import of the new law is to give the people the freedom of their choice, and the bill as it passed, does not solicit suggestions from anybody as to the best solution of this convention problem. The law gives every man who can qualify, the right to have his name placed upon the ballot, and The News believes, together with others, that the people of Washington county as well as over the state in general, are competent to cast their votes intelligently without the aid or consent of any ring or clique of politicians.

WALTER TOOZE of Wooburn, who is a candidate for congress in this district to succeed Binger Hermann, is off to the east to attend a fraternal congress, but before leaving he made some significant(?) remarks concerning his position on the tariff. Among other things he says: "It goes without saying that I will agree to no revision of the tariff not supported by the Republican party, and that, too, without the sacrifice of a single dollar to the laborers and producers of America. If trusts, by reason of a high protective tariff on any article of common use are robbing the common people, I am for prompt correction of the evil." Who is the republican party and who is going to tell Mr. Tooze when the trusts are robbing the common people? It would seem that if the tariff needs revision Mr. Tooze ought to know it now as do a great many other republicans, and express his willingness to be one of the republicans to revise it. The last speech of McKinley touched on the tariff revision; Roosevelt favors it, as well as all other fair minded republicans. That it should be done by the republican party is unanimous in the party ranks, and Mr. Tooze should have no hesitancy in stating that he favors tariff revision, also.


WHO'LL BE THE FIRST? THE following clipping is taken from the Record published at Roswell, New Mexico, and shows what is being done in that vicinity in the way of road improvement. It will be remembered that some weeks ago The News published a long article setting forth the same idea of road building that the accompanying item does; and which speaks for itself: "Since the rain the people on the East Second street road have been using the drags and the road simply looks fine as a result. In fact the road is in better condition than ever. And the beauty of the drag system is that, the longer the drag is used on a road, the easier is that road to be worked and the greater the benefit of one dragging. The R. F. D. people will drag that part of the road as soon as they can get the drag. The Commercial Club is arranging to have more drags made for this work. The secretary of the Commercial Club plans to organize a good roads club, to be composed of merchants and farmers. They will prosecute the work of dragging all the frequently traveled roads of the county."

This is just the time of the year that those in Oregon who wish good roads at a moderate cost, should begin to make preparations. It is so simple and economical that the experiment can be made by any farmer, and The News would like to publish the picture of the farmer together with the story of his experience, who builds the first quarter mile of this kind of road. Who'll be the first?
