TO REMODEL CONSTITUTION

Widespread Effort Being Made to Bring Seven Changes Before the Voters

(From McMinnville News-Reporter)

Through the initiative of the Oregon constitution, several proposed amendments to the organic law of the state will be offered to the electors next June, each to be voted on separately, and to be incorporated into the constitution if sustained by a majority vote.

They will be the first constitutional amendments that have yet been presented at the polls under the initiative, but the method will not be new, in as much as they will be voted on the same as were the direct primary and the local-option laws, enacted by that method last year.

They will be initiated by petition of electors, the same way as the direct primary and the local-option laws were initiated, on petition of not less than 8 per cent of the voters cast for supreme Judge in June, 1904.

An organization of 400 or 500 citizens is forming to boom the amendments, one of the most active members of which is W. S. U'Ren of Oregon City. The nucleus of the organization is formed by 17 men who have signed a circular letter directed to 1000 representative electors of the state, asking for their opinions on each of the several amendments.

Accompanying the circular letter goes a pamphlet presenting each amendment and setting forth the arguments therefor. The restrictions which the amendments would remove "perhaps were wise when the legislative assembly had exclusive power to make law," says the pamphlet. "But, now that the people have power to make laws (under the initiative), and to reject acts of the legislature (under the referendum), such restrictions can only operate to hinder the growth of better government." For example, the referendum on the general appropriation bill of the legislature, called for the purpose of cutting off the normal school appropriation, has demonstrated that the people should have power to call referendum on special items of an appropriation bill, without holding up the entire bill; the custom of passing special acts in the legislature for counties and towns on the sole recommendation of legislators therefrom, has developed a demand that the people of local districts have power to call referendum on such enactments; the malfeasance and unpopularity of officers of government has given rise to the demand that the people who elect them may remove them from their places of trust; the shutting out of the minority parties from law making bodies has produced the claim that they should be represented in proportion to their voting strength; the large emoluments of the state printer and the difficulty of reducing them through legislative amendments to the constitution has given rise to the sentiment that the people themselves should amend the constitu-
