Defining the Organization and Powers of the Common Council.

Be it enacted by the people of the city of Forest Grove That:

Section 1. At the first meeting of the Common Coun cil after the annual election in each year, or as soo hereafter as practicable, the Common Council shall choose by ballot one of its members to preside over the council and perform the duties of the Mayor in his absence or inability to act. He shall be designated as 'President of the council" and in the absence of the Mayor from the city, or if he be from any cause unable to act, said president of the council shall have and exertise the powers and perform all the duties of the Mayor and should both of said officers fail to attend any meetng, a quorum of the Council present may elect a Presi nt from their number for the purpose of the meeting. who shall be designated as President of the Council, pro

Section 2. The Council shall fix the time and place of holding its stated meetings, and may be convened by the Mayor or in his absence or inability to act, by the President of the Council, at any time.

Section 3. 




