The senate receded from its rate of 121/2 per cent ad valorem on the zinc ore and accepted the house rate of 10

The house gave up its demand that the woolen tariff rates go into effect at once agreed to the dates fixed by the senate, namely, woolen goods January 1, 1914; raw wool, tops and waste December 1, 1913.

The house receded from its provisions as to cotton threads, yarns and cloths, accepting the senate amendments, which revised the schedules on a new basis of thread count.

Income Tax Will Raise \$82,298,000.

According to estimates by treasury experts, 425,000 American residents must report to the income tax collector next spring exactly how much they owe the government under the new income tax law, which is embodied in the tariff bill.

The first returns do not have to be made to the internal revenue collectors before March 1, 1914. When the returns are made they will cover the incomes of citizens from March 1, 1913, to December 31, and the first payment of tax will be for money received during this period.

Ashland.-Material has arrived here for the preliminary work on the Foothills Irrigation company's project, and in a few days operations are planned to begin on the first unit of the Hyatt Prairie dam, northeast of Ashland. the breast of the dam will be nearly 50 feet high. It will be over 900 feet wide and will flood approximately 1000 acres to an average depth of 20 feet. The backwater created by this dam will reach nearly two miles.


