Eccles Sawmill Burned Saturday

Shortly after noon last Saturday the Eccles sawmill, located near the town of Banks, was completely destroyed by fire, as well as a large quantity of lumber piled near the mill.

The cause of the fire is not known. It is believed the loss will aggregate nearly \$100,000, partially covered by insurance. The mill was built two years ago, ran a few weeks and was closed down. In March, this year, operations were resumed. The mill belonged to M. H. Eccles of Baker City, who is expected to arrive at Banks within a few days. Until he arrives, it is not known whether he will rebuild. The company had been employing about fifty men and the destruction of the property is a severe blow to the employes, as well as to the town of Banks. Mr. Eccles a few months ago lost a mill at Baker, but this has been rebuilt.

IN THE NAME OF THE STATE OF OREGON. You are hereby required to appear before the undersigned, W. J. R.
