HAVE YOU REGISTERED?

Voters who failed to receive the state pamphlet containing constitutional amendments and measures will be reminded that they have failed to register and that if they wish to vote at the November election the time is short. Registration books close October 7 and the secretary of state says that the registration is 50,000 less than for 1914, showing that many voters neglected to register. Part of the pamphlets were mailed last week and the remainder were sent out on the 13th. They are only sent to registered voters.—Hillsboro Independent.

MR. ROBINS' WORDS

Back in October, 1914, Raymond Robins, who is now supporting the candidacy of Mr. Hughes, indulged in the following remarks, which, more or less must embarrass him in his present political attitude: "The most skillful, the most courageous, the greatest statesmanship of the last two years in this world was the manner in which Wilson averted war between this country and Mexico. The reason that the blood of American men—sons of our homes—is not today reddening the soils of Mexico, to serve the interests of a few corporation magnates

and speculators, is due more to the courage and constancy of Woodrow Wilson than to any other factor in American life. I would count myself poor and small indeed, if I were not able to recognize wisdom, courage and public service, even if it had been shown by the chief of an opposing party."
