## The Elliott Company Has Started Suit

According to this morning's Oregonian, suit for the balance due on a \$58,448 sewer contract and for about \$30,000 more in extras, necessitated by unusual working conditions, was filed against the city of Forest Grove by the Elliott Contracting Company in the Circuit Court yesterday.

One of the chief items of damage alleged is the harrassing and annoyance of men on the work by inspectors of Forest Grove, who are charged with attempting to extort money from the employes of the contractors.

The city engineer of Forest Grove and his inspectors, "particularly Inspectors Macrum and McKenzie," are the men against whom complaint is made, and their injury to the work is asserted to have been \$14,737.06. They are charged with giving numerous orders and withdraw them before they could be carried out, with causing the arrest of workers and have them held in jail without any charges being placed against them, and with attempts to levy tribute from the men.

The complaint was filed by Attorneys Clark, Skulason & Clark. The complaint asks that the city of Forest Grove be directed by the court to accept the work.
