School clerks will soon be taking the school census, if they have not already got the work well along.

There has been no gathering in town for several weeks as pleasant as the Valentine social at the Congregational church on Wednesday evening. "Living Pictures" were exceptionally good. The house was crowded, too, which was satisfaction for the managers, since the profits depended on patronage.

A new school district has been organized near Middleton, including the east half of section 34, all of section 35, T. 2 S. R. 2 W. and the north half of section 2 T. 3 S. R. 2 W. and a hundred acres in section 3 T. 3 S. R. 2 W., lying in Yamhill county. The board of directors is Charles Barrett, Christ Holsenick and John Chapman. The clerk is Allison Wright.

The Hillsboro Republican Club will, for the present at least, meet in Grange hall on Main Street. The discussion for next Tuesday evening is the subject of "Free Love Material." Mr. L. K. Adams will lead in the debate. The public generally is invited to attend. This includes the ladies, who are quite as much interested in good government as their husbands, fathers or brothers.

A class of forty-seven teachers reported for examination as applicants for certificates on Wednesday morning last. The number of applicants was far greater than expected, wherefore there was some scheming on the part of Superintendent Stanley and his assistants to find accommodations for the crowd. The few papers examined are said to be of high grade. The questioning will not be completed before this afternoon or tomorrow morning.

The Hillsboro band has fitted up a band room in the wooden building on Second street, formerly occupied by the postoffice, where two nights in the week are devoted to practice. They have bought one or two new instruments and are now equipped for furnishing music at parades, celebrations and outdoor and indoor meetings. To help pay the expense thus incurred, the boys will give a grand ball on the 22d inst. at Hillsboro opera house.

A letter from Beaverton, after mentioning a business transaction, has the following words touching the raising of the subsidy for the Portland-Beaverton motor line, and while the lines were not opened for the public, it is considered that no confidence is violated when they are printed. Especially is this proper since a true statement is conveyed. The correspondent says: "The motor movement is progressing fairly well. There are two or three that are holding back and have not put down their subscriptions, as they should, and we find about the same number that have large and valuable holdings that have not signed in proportion to their neighbors, nor in proportion to what their immediate benefits will be. With these few exceptions all have done nobly, and it is hoped that the few alluded to above will be able to see that they are likely to overtake the great and much needed enterprise, as it has reached that point where their help would make the subsidy a sure and settled fact, but without their reasonable share it is almost impossible to reach the amount asked, and the ground has been carefully worked over and all have done about all they can."

That the youngsters may know when the hour arrives, the whistle at the night & day station is now blown as a signal that the time for going home has come.

The attendance in the primary room of the public school is so great, that the pupils have been divided into two classes, one attending in the forenoon and the other in the afternoon. This works a hardship on the mothers who send their four-year-olds to school, since it requires their care and attention for an extra half day.

The Washington county medical society met on Tuesday of last week in Forest Grove, and among other things adopted the following resolutions: Resolved, "That when a physician presents his bill to a patient and such patient refuses to make settlement either by cash or note, that such person's name be reported to the society and medical aid denied."

MAKES ANOTHER MOVE.

McMINNVILLE, Feb. 14.—Silently and without warning, almost, Andrew Shuck, one of the early pioneers of Oregon, slipped away Saturday evening into the great beyond, which is now being rapidly peopled with the sturdy spirits of the men who carved a place in this great western country, called it Oregon and added its star to that flag which is the representation of liberty and the highest achievement of man.

His death was unexpected, and while his many friends knew of his sickness it was not thought that the end was so near, and the tidings as it spread brought a look of surprise and sorrow to the hearer. Death was caused by acute inflammation of the bowels. Mr. Shuck, having been troubled more or less with a bowel complaint for years. To all appearances he was enjoying his usual good health to within two or three days previous to his death, and his absence from his usual haunts produced the query, "Where is uncle Andy?" to which was replied by his pioneer friends, "a little under the weather."

Andrew Shuck was born in Indiana on the 19th of June, 1815. In 1835 he moved to Iowa where he married his present wife, Miss Mary Conway, in 1838. He resided in Iowa until he started for Oregon in the year 1847. Upon his arrival in this state he settled on a donation land claim near North Yamhill, the same being now occupied by his sons William and Reuben. He took an active part in the early politics of the state and was appointed sheriff of this county by Governor Lane during the territorial government.

Since then he has twice filled the office with credit to himself and the democratic party, of which he was an ardent follower. The people of this county sent him to the state legislature six times, and they profited by the trust reposed in him, for the man does not live, we believe, that can cast an aspersion upon his life or political character. During his late years, "Uncle Andy" as the present generation was pleased to call him, did not take an active part in the politics of the county, but his voice was always heard in defending what he thought was right. He was a firm believer that every man should take a part in public affairs, and through his own life made a public man have received the same consideration given his private affairs. If more men in this community were built on the same lines our public affairs would be conducted in a much better manner.

While Uncle Andy was proud that he was a "mossback" in the estimation of some men, the very act of his coming to Oregon when the state was not a state, in fact nothing but a wilderness, proving that he was just the man to the sturdy independence of thought and action of such men as Uncle Andy Shuck and his brother pioneers, is due the present commonwealth of Oregon; one of the greatest and grandest of the nation. To the present generation should give thanks and praise for blazing out a trail. The remainder of us are but followers.

The deceased, whose maiden name was Nettie May Thomas, was born April 25, 1873, in Otero county, Nebraska, and with her parents came to this state and county when about four years of age, where she has since resided. She married Charles Holcomb November 20, 1892. She embraced the Christian religion about two and a half years ago. For the past year she has been afflicted with a great sorrow, and was anxious to meet death, that she might be at rest in the world beyond, for which abode she had made ample preparation.
