JOHN MARSHALL IN THE CONSTITUTION.

A half-holiday was declared on Monday afternoon in order that the people might appropriately celebrate the 100th anniversary of the appointment of John Marshall as Chief Justice of the Supreme Court of the United States.

John Marshall was born in the state of Virginia in 1755. His father was a friend of George Washington and served throughout the Revolutionary war as the colonel of a Virginia regiment.

In 1788, the question of the adoption of the constitution was to be determined by the state of Virginia. Eight states had already ratified it. It required nine to make it of binding force.

He was appointed Chief Justice of the Supreme Court of the United States on the 31st day of January, 1801, and took his seat on the fourth day of February.

The first great case which came before him for decision was the case of Marbury vs Madison. In this case, he had to decide the great question of what is the duty of the judge when a law comes to him that is contrary to the constitution.
