Dr. Adkins has in his dental rooms one of the new gold crown swaging machines recently invented by Dr. Lyon and now manufactured in East Portland. The machine greatly simplifies the labor of fitting gold crowns on teeth. Blanks are cut from sheets of gold with a punch greatly resembling a gun wad-cutter. These blanks are from the size of a gun wad to smaller sizes. These are put in the machine and a thumb is first formed. Then the second part of the machine is brought into use. A plaster cast of the tooth to be capped is taken. A reverse cast of the plaster tooth is made of a metal that is not very different from common rabbit metal. In truth it is a mold. The gold thimble is then filled with wax. A piston is then pressed on the wax. This pressure and compression on the piston with a mallet forces the gold into the mold where it assumes the very shape of the tooth which it is to crown. A perfect fit is secured. Dr. Adkins now does in a few hours what took days before he got the machine.

John C. Cory, of Cornelius, stepped off the east bound train last Friday morning where it meets the west bound. He neglected to get on again till after the train was in motion. Then making a grab for the supports to the steps he missed with his left hand but caught the iron rod with his right. He was not able to recover but retained his hold and was swung around so that he was dragged over the ties for forty or fifty feet. He then let go and rolled limp off the track. Dan O'Neil, the veteran steam-boat man, is the purser on the Bailey Gatzert running between Portland and The Dalles. Dan came to Oregon in 1849 with the regiment of mounted riflemen that came West that year. The next year, 1850, he was Census Enumerator, under the supervision of Jos. Meek, who was U. S. Marshal of Oregon. O'Neil's enumeration district was the counties Washington, Yamhill, Polk, Benton and a part of Clackamas. The hardest trip he had that summer was as a deck passenger on a cayuse pony into Douglas county to list the members of the three Applegate families that had squatted at what is now known as Yoncola. The compensation for the whole work was \$1500. Dan next took employment on the little river steamer Columbia plying between Portland and Astoria. The fare between those towns was \$25.00 and such a thing as a reduction for a round trip ticket was not known. In those days people took no river excursion trips for pleasure. When a man went aboard a river steam-boat he took a voucher for his transportation and meals and charged expense account at the business office of his firm. Recreation then was only an incident. Running with Capt. O'Neil on the Bailey Gatzert is Reub Smith engineer who controlled the throttle on the little Columbia in 1851. It is believed that these cronies are the oldest steam-boat men in service today. Both are white headed, but the vigor of early manhood is yet with them and Dan receives the \$1.50 charged for the fare between Portland and The Dalles as he did the \$25.00 paid fifty years ago for a passage of the same distance to Astoria, and Reub with as great skill controls the big engines today as he did the little Columbia's motive power in 1851.
