Mr. Jos. Hare has a gang of 12 men in the timber tributary to the Tualatin above Gaston cutting saw logs for 1902. As soon as teams can be spared from farm work they will be used to put the logs in to the river. From there they will be floated to the mill at the time of the first fall rains in November. About one and a half million feet of logs will be cut out of that very superior forest.

When the president of the Southern Pacific was in Oregon a few weeks ago, he announced that passenger fares over his roads in Oregon would be reduced from 4 cents to 3 per mile. Agents have received a circular instructing them to commence using the 3 cent fare on Sunday, June 1. The rate, then, from Hillsboro to Portland will thereafter be 65 cents instead of 85, and from Hillsboro to Cornelius will be 10 cents instead of 15.

Mrs. J. M. Greear, who is visiting in Indian Territory, was there in time to enjoy (3) a taste of the destructive cyclone that last week twisted through that section. Mrs. Greear was not directly in the path of destruction, but the outer edge was enough. Such a wind and such lightning and thunder made her long for her quiet, Oregon home. Mrs. Greear will extend her visit into Texas, and when she returns she will be accompanied by her mother who plans to make her home in Oregon.

The eleventh annual excursion of the Order of Railroad Conductors will be run from West Side stations to Salem by way of Portland on Sunday, June 8th. Going toward Portland, the train will pass the Hillsboro station at 7:40 a. m. There will be a match game of base ball in Portland that day between the Portland team of champions and Spokane lunch-grocers. Arrangements have been made so that those holding excursion tickets can stop at Portland and catch the train on its return from Salem. Tickets for the whole trip will be sold for \$1.60.

Dr. F. J. Bailey, who is on Cebu Island, Philippines, in charge of a hospital, has been appointed assistant surgeon in the army with rank of captain. The appointment will without doubt be confirmed by the senate. This promotion is in recognition of the good work he has done during the past two years not only on the transports but also in the army hospitals on land. Of course we all remember Dr. F. J. as our Frank, son of Dr. E. A. Bailey, who has during the last 30 years been with so many of us when we were sick and fast losing interest in worldly affairs. This commission will probably be accompanied with a furlough that will permit Dr. Frank to visit in Hillsboro for a few weeks.

Gales Creek is a thriving hamlet that is becoming more important every month. There are two general country stores maintained there as well as several shops. One of these is equipped with power generated by a 25 foot head of water. The output is those useful articles usually made of wood, furniture for house furnishing predominating. The hills break away just above the village so that there is a valley of a mile and a half in width and five or six the other way. The farms are not only beautiful but very fertile. One farmer stated that a new field growing its first crop of wheat sown on the ashes of a slushing would yield 40 bushels to the acre. Next year he will run it to clover. That means that the dairy interest predominates there. A good school is maintained, taught this summer by Prof. Case who was here two years ago. The need of the neighborhood is transportation, though the wagon road to Forest Grove is about the best in the county being gravelled all the way with wash gravel from the creek. The supervisor had several teams hauling gravel this week with which the ruts are filled and the road leveled. Several complained that the money now paid for road work is not building as much road as the old labor system.

After being "closed for repairs" for 19 weeks, the Climax Mills are again making flour. Since the mills were first started some fifteen or more years ago, no readjustment of machinery has been made. This summer the company took advantage of the time necessary for overhauling to install some new machinery and to increase the capacity of the mill. What was a seventy-five barrel mill is now a hundred barrel plant. The object to be attained by this expense of \$2,500 was to secure a larger output of a better grade of flour from a less quantity of wheat. After a few days run it is believed that all this has been accomplished. The rearranging of line shafts and elevators has so economized power that another set of rolls are operated with the same engine. The old holting reels have been thrown out and a new sifting device adopted. Flour and bran is now separated just as our mothers in their well-ordered kitchens removed the bran from the cornmeal that went into the breakfast Johnnycake, only the sifter instead of being ten inches in diameter is about twelve feet. The Climax flour that before was white is now whiter, more is got from a bushel of wheat and it makes a more puffy roll. There are bigger mills in the state, some just as good, but none better. The Climax comes to be a country mill and takes its place with the city mills that supply the export trade and the best city custom.

The Quarterly of the Oregon Historical Society for March 1902, has been received. Its contents are as follows: "The Social Evolution of Oregon," by Prof. J. R. Robinson, of the Chair of History, Pacific University, Forest Grove; "Political History of Oregon From 1865 to 1876," by Hon. W. D. Fenton, Portland; "History of the Barlow Road," by Miss Mary S. Barlow, a grand daughter of Samuel Kimbrough Barlow, the builder; "Across the Continent Seventy Years Ago," compiled from the papers of John Ball by his daughter, Mrs. Kate N. B. Powers. John Ball taught a school at Vancouver in November, 1832, and was the first school teacher on the Pacific coast. All these articles are vitally important as relative to the history of Oregon.
