Eastest of access among all the Canons of Colorado, being situated on the main line of the Denver & Rio Grande between Canon City and Salida in the front range of the Rockies, is the most spectacular, awe-inspiring and magnificent. Down this mighty cliff in the heart of the granite rock-barrier rush the raving waters of the Arkansas River, dashed into foaming fury and dashed into spouting spray by its swift descent through the tortuous defile. So narrow is the passage at one point that there was no room for both the road and river, and therefore a curiously constructed bridge of steel had to be thrown lengthwise of the stream, suspended from iron supports mortised into the canon walls on each side to the right and left. And right here can be seen the climax of all the canon's grandeur, that which has been aptly called "The Royal Gorge." For two thousand six hundred feet the solid monoliths soar upward—five times as lofty as the Washington Monument, the highest permanent structure reared by the hand of man. No words can adequately describe the magnificence of the scene. Only those who have beheld its glories can appreciate them.
