In the evening special music by a double quartet and instrumental music is expected. The pastor will speak on "What the Public Schools, the State and the Church Owe Each Other."

The annual conference of the United Brethren church will convene at Philomath, Benton county, June 18, and will be presided over by Bishop Barkly. Rev. Walter Reynolds of the Hillsboro circuit will start for the meeting place on Monday next. He has been here four years, and does not expect so good a fortune to come to him as to be returned to this field of labor. Many friends have been made during the past four years, who will miss the very pleasant associations that are now to be discontinued.

Mr. John Jack's residence, on his farm near Farmington, was entered by a tramp on Tuesday afternoon between 2 and 3 o'clock and robbed of \$10 which was in a pocket of holiday pair of pantaloons. The fellow was about six feet tall, smooth shaven and wore a black coat. Mr. Jack reported his loss at the sheriff's office late the same evening but no trace of the pilferer has yet been found.

Last Monday Mrs. W. V. Wiley was, by telegraph summoned to attend what has since proved to be the last illness of her father, Charles McKinney, who was with his son Chas. V. (Chuck) at Durkee, a station on the O. R. & N., 27 miles beyond Baker City. Death occurred on Wednesday, June 11. The remains will be brought to Hillsboro for burial. The funeral services will be held at the residence of W. V. Wiley tomorrow at 10 o'clock. The deceased was of the immigration of 1845. At risk of being put in the old foggy class, the Independent admits that it has not yet been able to see why arbitration of differences between organized capital and organized labor shall be adopted. Disputes over matters that have occurred in the past are proper subjects to go before an arbitrating jury but how can future disputes be discussed now, before all the facts or any if there be, can be submitted? How can it be decreed that a manufacturing industry shall pay a fixed sum for a days labor when it cannot be known that there will be a fixed market for the output. Contracts? Yes but these contracts have been taken on the basis of the old labor scale. What the Independent desires is that there may be free competition among factories, and free competition among laborers. If a man cares to work when he does not wish to associate with a labor organization, he ought to have the privilege of so doing. Everyone recognizes the laborer's right to quit work when he chooses and he ought to have the same right to begin work.

At 7 o'clock last Monday morning when the convict laborers at the penitentiary at Salem had been marched into the foundry and were about to take up their tools to begin the day's labor, two convicts, Harry Tracy and David Merrill, sent from Multnomah county for 14 and 20 years respectively, produced Winchester repeating rifles and shot guard Frank B. Ferrell who fell dead. A life convict, Frank Inghram interfered to aid the guards and was shot in the knee. It was thought at first the wound was fatal, but the patient's life was saved by amputating the leg, and he is now reported to be doing nicely. Tracy and Merrill then made a run for the wall shooting guard S. R. T. Jones on his post. He is dead. The convicts put a ladder to the wall and quickly climbed over. On the outside guard B
