On Friday afternoon a swimming exhibition was an event at Portland. A professional advertised that at about three o'clock p. m. he would swim the river at the point where the Morrison street bridge spans that stream. Thousands of spectators stationed themselves on the bridge. As the swimmer approached the East Side the crowd there became more dense. At that time three river men in a boat thought to have amusement by rocking their craft and falling into the water. Some one called "man drowning." Those on the bridge rushed to the railing to see. The weight caused the railing and bridge side walk to collapse. About 100 men, women and children fell to the water below, a distance of about 40 feet. The rescue was prompt, though many sustained injuries. Three were drowned, a boy and two women. Our Wm. Bagley was on the bridge, one foot on the plank that went down. He fell backward on the bridge and escaped a ducking. An examination of the bridge shows that it was safe for ordinary traffic but that day the weight was extraordinary.
