FROM SALT LAKE CITY.

Letter from Irving Bath Who Stops Off on His Way to the World's Fair.

Salt Lake City is and ever has been the object of much interest to most people. Probably because it is principally inhabited by the Mormons. A great many people believe that the Mormons are different from other people in appearance and manner. As far as I could see in a stay of a day and a half, I could not see any difference between them and the Oregonians, aside from their religious place. The city proper is a very beautiful place. It is situated about 14 miles from the lake and is built on a grade. One of its most important items of interest to the tourist is its streets and blocks. The streets are over twice as large as those of our large cities and the sidewalks are 25 feet wide. On each side of the street is a stream of water flowing, probably furnished from the mountains. These streams are on every down-town street and on most of the side streets. The water keeps the streets free from dirt and the scrap-paper that is found in most places. To look down these great broad avenues with their tall buildings is a sight that impresses the visitor. In accordance with its broad streets the blocks of this city have an average of more than four times that of the usual-sized blocks. Very few cities of the size of Salt Lake City have telephone and electric light poles strung on each side of and in the center of the streets. This makes three rows of poles to each street.

Everybody has heard of the big temples erected by the Mormons. In the central part of the city is a ten-acre tract of land, walled in. Inside of this are the Mormon tabernacle, temple and assembly hall; there are also the Bureau of Information and a few smaller buildings. The wall that surrounds these buildings is fourteen feet high and one-half inch thick and made of sun-dried adobe bricks. There is another wall inside of this outside wall that encloses the temple; this is not so high but has an iron fence on top of it. The buildings erected by the Mormons are all old in appearance; the temple, which has numerous spires and steeples, is made of pressed material and is a beautiful structure; the tabernacle is the reverse of the temple, having a low, oval-shaped roof. The Mormons own the railroad running between the beach and the city, the street railways, a large part of the business section and the Salt Lake Pavilion. These amount to many millions of dollars and are not taxable by the city.

Saltair is the resort of all summer people. It is built out on the lake and is a very large building. The largest hardwood dance hall in the world is on the upper floor; it has a capacity of 1,400 couples. I was present Saturday night and agreed with all present that it is a great amusement institution. The Mormons believe in dancing, and before the dancing commenced a prayer was offered. Numerous side-shows, shooting-galleries, bowling-alleys, etc., are in this building. It cost a quarter of a million dollars and is of Moorish design. Hundreds of waiters are employed at the refreshment stand which occupies all of the lower floor. The Mormons must be a law-abiding people, for during the time I was there never saw a policeman or heard any disturbances, and there were thousands of people on the streets and at Saltair. Salt Lake City is 4,500 feet above sea level and has a moderate climate the year around.

Mrs. James Roberts, a well known and highly respected old timer of Oregon, and a resident of Hood River, died last week, of paralysis, after a few weeks' illness and was buried at Pleasant Hill cemetery.

Where usually two and even three crops of clover is obtained from the same field in one season, the same land has yielded but one crop, and a poor one at that, this season, owing to a lack of sufficient moisture at the right time.

If one desires to know the value and scarcity of good timothy hay in this vicinity he will find that it is not to be bought, scarcely at any price, in fact a great majority of farmers are depending upon straw and clover for their winter's feed for stock.

Stewart Vaughn, Steve Poole, and Mike Foster returned a few days ago from Ocean Park, Tillamook county, where they have been clam digging and rustling salmon (at 75 cents per fish) and other excitement galore for the past two weeks.

A number of young people from Middletown attended the celebration at Newberg, and in the meantime measles has developed in the Harrington, Hardin, McDaniels and Eby families, in fact the disease has become epidemic in that locality.

Mr. Elwert, an aged man of Middletown, was seriously injured recently by his wagon-reach breaking in descending the hill at the depot. He was seated upon the open-running gear behind, and was pitched forward upon his head and shoulders, the impact causing a number of serious injuries. However, he has so far recovered that the attending physician thinks he is out of danger.

A narrow escape from fire occurred during the week in which the drug store was involved. An unknown urchin started a blaze in an old, decayed, dry, log lying alongside of the building, which fortunately was discovered in time to prevent damages. The identity of the lad is yet unknown, and whether the animus that incited the deed was pure curiosity or a direct attempt at arson is questionable, but the future career of this particular chap, in that direction, may cause him serious trouble.
