Even chickens are not raised extensively, each farmer has enough to supply his own wants and lets the town folks go to the devil for their poultry, and to the Valley for vegetables. We are glad to say prairie chickens are becoming more plentiful, we saw about half a dozen last week scattered about.—Wasco News.

Supt G. S. Morgan, of the city electric light and water plant, brought to this office yesterday morning a branch fourteen inches in length, cut from a Bradshaw plum tree growing in his yard, corner Second and Jackson street, which contained eighteen magnificent plums, the smallest of which was as large as an ordinary sized turkey egg. We have never seen anything to compare with the sample handed us, and the only regret is that we cannot show the branch as it now is, to some of our Eastern friends who are slow to believe that the fruit of Oregon beats the world. In fact it needs to be seen to be appreciated.

If our readers will step into the Bailey drug store they will see a can of figs which are not only a scarce article in Oregon but holds over any fruit of that variety ever grown in this section. The can contains about a dozen large figs, which were grown by Andrew Heckman, of Bethany, and presented to Recorder Kuralt, who had them canned and will deliver them over to Mr. Wall for exhibition at the state fair, and should certainly draw a prize. The trees from which these figs were taken bear two and three times a year, and the yield is large. The late Jacob Brugger planted the fig trees from which this particular fruit was gathered.

The marriage of Miss Mary E. Connell and O. G. Barlow took place at the home of the bride, in Portland, Wednesday morning, at 8 o'clock. Immediately after the ceremony they took their departure for Victoria, B. C., where the honeymoon will be spent. Miss Connell is well known in this city, and has many relatives and friends who will wish them a long and happy wedded life. Mr. Barlow has been a Washington county resident many years and is the owner of valuable farm property near Glencoe. His friends here are laying in an assortment of stuffed clubs to greet him on his return. They are glad he is married and wish him and his bride all the happiness in the world, but they are of the opinion he was just a trifle too shy about it and needs a dressing down.

The rush to the coast and mountains continues and more people are going to Newport and the Cascades than ever before. Up to Wednesday of last week over 125 tents have gone in the baggage cars of the Corvallis & Eastern railroad from this city to Newport for people who will camp at the seaside for the season, and the rush seemed at that time to be fairly beginning. More baggage has been taken to Newport this season than in any former season and more passengers have been transported than ever before. Trains take from 150 to 250 pieces of baggage and three to four cars loaded with passengers who are going to the seaside. Other summer resorts, such as the Cascade Springs and the mountains on the Santiam, are securing their quota of summer guests and the railroads are crowded with this class of travel.—Corvallis Gazette.

A large number of guests and friends were present, and the gifts were numerous and valuable. The couple took the afternoon train for Portland where a wedding dinner was served at the home of Dr. L. B. Smith, after which they departed for their home at Long Beach.

A big mass meeting was held at the Auditorium in Newport last Tuesday forenoon for the purpose of devising some means whereby Nye Creek can either be divorced from Newport or be permitted to receive her share of recognition in the way of improvements. Hanged in Washington County.

While cleaning up the vault in the county clerk's office this week Mr. Godman ran across a document which tells a tale of Washington county remembered by few people living here now. It is only a scrap of paper, but it was of vital importance to Creed Turner fifty-three years ago. The paper reads as follows:

Territory of Oregon, County of Washington.

Washington County District Court, October Term, A. D. 1851.

To the Sheriff of Washington County Greeting:

Creed Turner, a prisoner now in your custody under sentence of death for the murder of Edward A. Bradbury, you will safely keep in the jail of your county until Thursday, the Fourth day of December proximo, and on that day, him take hence to a gallows for that purpose to be erected near said jail, and at precisely the hour of eleven o'clock on the morning of Thursday, you will then and there hang him by the neck until he is dead. After which, the lifeless body of said Creed Turner you may deliver to his friends on request; but if no such application be made, you are then commanded to inter the same decently and orderly, and at the public charge.

Given under my hand in open court, this 1st day of November, A. D. 1851.

O. C. PRATT, Judge 2nd Jud. Dist.

On the reverse side of this document was written the following:

I hereby certify that I executed the within as commanded, this 4th day of December, A. D. 1851.

Creed Turner was convicted of the murder of Edward A. Bradbury at Saurer Island in Washington county on the 19th day of October, 1851.

A Dangerous Adventure.

A party of six men on Monday went out near Netarts bar in one of Geo. W. Phelps, boats to the S-a Lion Rocks off Cape Meares lighthouse, to explore the picturesque home of the numerous birds and sea lions. It is a venturesome and dangerous trip to make in a small boat even in fine weather and when there is not a ripple to be seen on the mighty Pacific. The party included D. B. Reasoner, D. Burkhalter, Wm. Wall and H. Schulmerich, of Hillsboro, Or., R. Lockwood, of Forest Grove, and H. M. Reasoner, of Reasener, Iowa. They had a successful trip out to the rocks, and some of them landed and succeeded in reaching the uppermost part of the rock, where they found a large number of bird's eggs and interesting things. They captured several young birds and killed a number sea lions, there being thousands in the vicinity of the rocks. On coming back over the bar a little incident occurred which made them hold their breath and proved to them that a person was running considerable risk of going to Dave Jones' locker when taking a trip to the seal rocks in a small boat. While on the bar, the little craft came in contact with one of the breakers, and for a few seconds there was consternation on board. It nearly filled the boat with water and drenched the occupants, and it was fortunate for the party that it did not come into contact with another breaker immediately following the one which first struck the boat. They, however, managed to get in without further mishap and glad to find their feet again on terra firma.—Tillamook Head-light.
