The Hillsboro Amusement Association yesterday purchased the lot on the corner of Third and Main streets, where once stood the old Washington Hotel, the consideration being something over \$600. The association will now break ground for the new opera house, a building Hillsboro has long needed. It is expected the structure will cost, including the lot, \$3,900, but the seating has not been provided for, and the association propose to give a series of entertainments and dances to meet this expense, and it is hoped the public will respond liberally. The first benefit dance will be held on Saturday evening, April 8th. Let the public show by their attendance that they appreciate the efforts of the Hillsboro Amusement Association to give this city an up-to-date opera house.

Rev. J. Wilbur Chapman of New York city, assisted by a large number of local and visiting clergymen, is holding revival meeting in Portland, which are being attended by immense crowds both afternoons and evenings. Dr. Chapman, who has been holding revivals in California, arrived in Portland Wednesday, said to a reporter: "I have not, in all my ministry, seen such awakenings as I have been privileged to have a share in since last October. If there has been one distinguishing feature in all this work, it has been the unparalleled interest of the men in spiritual things. I have preached to more men during the past three months than ever before, and they have literally seemed to be hungry for the gospel. They are getting sick of sin and have a growing sense of the need of the Saviour." These revival meetings will continue for several weeks.

A Hillsboro correspondent of the Telegram sizes up the athletic situation in this city for the coming season as follows: "The Hillsboro Athletic club, which just closed a very successful football season, will put out a first class track team this year. They have just finished a fine eight-lap track and expect to have the club house remodeled soon. They have a few local meets scheduled, but are looking for larger game. Several good sprinters are listed as members of the club, among whom are Cate, the old Corvallis star; Huston, a former Pacific university man, and Freeman. Cate, Humphreys, Robinson and Huston are doing good work in the running broad jump, and Wethered in the high jump. Humphreys is depended on for the 440. In Bradbury, Hillsboro has an exceptional good half-mile and mile runner. Archibald is expected to take care of the weights, Bradford and Robinson are going high enough in the pole vault, and frequently beat the score made in the recent Columbia Y. M. C. A. meet at Portland, and great things are expected of them."

Surveyor A. A. Merrill is up on the Columbia county line doing some surveying for the county and will probably be absent about a week.

Mr. and Mrs. Wm. Mendenhall left Wednesday for Klamath Falls, where Mr. Mendenhall will take a position in the electric light plant of H. V. Gates.

President Earling, of the Chicago, Milwaukee & St. Paul railway, says that his company will extend its line to Portland, and that \$300 will be built this year.

Frederick Maletz, of Phillip, died last Monday and the funeral was held on Wednesday, the burial being in the Phillips cemetery. Mr. Maletz had lived there for the past eighteen years. He leaves two children, a son, who lives in California, and a daughter residing at Phillip. His wife died just a year ago.

H. Tideman, a bridegroom in the employ of the Southern Pacific, near town, fell from a bridge to the ground yesterday afternoon, striking on his head, receiving serious injuries. Dr. Linklater was summoned, and after doing everything possible for the unfortunate man, ordered him sent to the hospital at Portland.

Secretary Richardson of the Oregon Development League, has called off the meeting advertised to be held in Portland April 4 and 5, because the railroads would not grant a one-fare rate. Of course we do not pretend to know the business of these great corporations, but to a man up a tree it looks as if they were losing money by discriminating against Oregon, for had the league meeting been held, thousands of people would take advantage of the low rates, and the companies are losing many dollars by this decision.

The Oregon Condensed Milk Co. have received samples of their new labels and they are certainly the swiftest thing of the kind ever put on the market in this neck of the woods. The label for the "Oregon Grape Brand" was designed by Mrs. Tamiessie and Miss Rose Wilcox. It has a splendid picture of Mount Hood in the center, surrounded by the Oregon Grape in full bloom, with a background of deep blue. The company have also erected a sign, 91 feet long, over the new warehouse, at each end of which are immense cans six feet high. On these cans are painted the new label. Mrs. Tamiessie and Miss Wilcox are to be congratulated on their work of art. Died at Los Angeles.

Last week mention was made in The Independent of the death in Los Angeles of Mr. A. J. Hamilton. Mr. W. L. Jones, at one time a resident of this city and a former owner of this paper, writes further particulars of Mr. Hamilton's death, as follows:

Mr. A. J. Hamilton, a pioneer merchant of Oregon and for many years postmaster and railway station agent at Beaverton, Washington county, died at his temporary residence in Los Angeles Saturday afternoon, March 11, aged nearly 70 years. Mr. Hamilton removed from Beaverton to Portland several years ago, and engaged extensively in real estate and building until the failure of his health, which finally led to his going to Los Angeles. Accompanied by his aged wife, he took up his residence near the Hope street Congregational church, of which denomination he had been an active worker for half a century. Just prior to his death he was planning with his devoted companion for the celebration of their golden wedding anniversary.

For a long time the deceased had been a sufferer from partial paralysis. The funeral rites were held in the Hope street church, after which the body was cremated, in accordance with his expressed wishes. Mrs. Hamilton is bearing up bravely under the sad affliction and will soon return to her home in Portland. Mr. Hamilton came of a prominent family of educators, was a man of integrity, culture and refinement and his forceful character has left its impress upon the communities in which his life work called him.

Freidrich Seidle, an old Oregonian and pioneer died at the home of Mr. Schneller in this place Saturday afternoon from acute pneumonia and general debility, after a short illness. He was a bachelor and had made his home with the Schneller family for the past twenty-one years. Rev. A. Spiles preached the funeral sermon at the family residence Monday and the remains were interred in the German Lutheran cemetery one mile north of town. He was aged 80 years and born in Germany.

Joe Huffman, a young farmer residing south of town left Saturday for the Sumpter district where he expects to engage in mining or some other occupation other than farming. The latter he considers too slow unless one is sole owner and proprietor.

The post office has been temporarily removed to the building lately vacated by Mr. Slater while construction of a new building is in process where the post office building now stands.
