It is announced that all passenger locomotives on the Harriman lines in Oregon, with the exception of those running on the O. Passengers on these lines need hereafter have no fear of cinders, for oil burners do not scatter them.

Figures compiled by the Harriman officials shows that the number of passengers handled by the Southern Pacific out of St. Francisco to main lines and interior points, not including Oakland, Berkeley and Alameda, for the eight days succeeding April 18, the day of the earthquake, totaled 115,295. Of this number, 78,560 passengers were carried free.

Mrs. Bradford has taught, spoken and organized in thirty states and is also well known as a writer."

George Clayton Hurt.

George Clayton, expert machinist for the Morse-Fairbanks Engine Works, who has been in Hillsboro for several weeks putting in the big engine for the Oregon Condensed Milk Company met with an accident last Saturday which nearly cost him his life. Clayton is subject to fainting spells, and while working about the engine became dizzy and fell against the big balance wheel.

His clothing caught on the shaft and as quick as a flash, he was pulled in, thrown over the wheel and up against a solid embankment of earth, every stitch of clothing being torn from him. He was rendered unconscious for about half an hour, when he revived enough to call for help, attracting the attention of a Mr. Geisner, who was working across the river, and he once came to his assistance and summoned Dr. Tamiel.

The injured man was taken to the residence of L. W. House, where he now is. Dr. Linklater was called in for consultation and upon examination it was found Clayton had received several bad cuts, one on the chin and another under the eye, which required several stitches. The first finger of his left hand, which was caught in a cog wheel, was badly crushed and had to be amputated at the first joint. Besides the cuts he was badly bruised, the effect of being thrown against the embankment and the force in tearing off his clothing, and it will be some days before he will be able to be out again, though he is slowly improving. He carried an accident policy which provides for just such an emergency, and the Portland branch of the Morse-Fairbanks Company have written him to take plenty of time in getting well, as his pay will go on just the same. It was a very close call for Mr. Clayton, and he will not likely forget.
