Mrs. Geo. O. Sloan has brought suit against the city of Forest Grove for \$150 damages. In her complaint she says that while she and her sister, Miss Cynthia Buxton, were driving along main street, a culvert gave way beneath their horse, and they were thrown violently over the dashboard and into the street. She asks for \$100 for injuries received by herself and sister and \$50 damages done to the rig.

Lowell Markee came near having a serious accident a few days ago. He had been taking honey out of a case and still had the knife in his hand. In lifting the box his hand slipped and the knife struck his forehead just above the right eye making a cut about an inch in length. While it is not a serious injury it was a very narrow escape for the eye.—Forest Grove News.

Abner Hembree, who has been confined in the Yamhill county jail, awaiting trial at Tillamook, July 24th, for the murder of his wife and daughter at Sand Lake, last fall, has been taken to Tillamook by the sheriff and deputy of Tillamook county. His case will come to trial next Wednesday, with Geo. A. McBride, judge.

Judge Cleland, of Portland, last week handed down a decision that the Pacific University of Forest Grove is legally entitled to the gift of \$25,000.00 that institution by D. K. Abrams, July 31, 1903. Mr. Abrams was 77 years of age, and in the action brought against the University to prevent the payment of the money, it was claimed that he was not capable of transacting business affairs at the time.

Mrs. Greffield, for the first time, announced Thursday morning that her belief in Holy Rollerism was shaken. "Since my husband's death," she said, "I have come to the conclusion that many of its teachings were funny, and with it's founder dead and myself in jail, the religion will come to an end." Her jailer says a great change has come over her, and the spell of fanaticism has seemingly vanished.

One evening last week, Mr. and Mrs. J. A. Messenger were eating supper on the porch of their home, on the farm recently purchased west of the long bridge. The floor of the porch was badly decayed and Mrs. Messenger broke through, falling to the ground several feet below. She was helped up by her husband and though somewhat frightened, was not injured to any extent. But after Mrs. Messenger found out that she had fallen on the ground only a few inches from an open well, measuring eight feet across, she was still more frightened. Had she dropped into the well, she would certainly have drowned. When Mr. Messenger purchased the farm, nothing was said about the well, and he did not know of its existence until the accident occurred. It was a close call.

J. Whyte Evans, ex-president of the United Railways Company, was run down and badly injured by a Washington streetcar, at Sixth and Washington streets Sunday afternoon. For a time it was thought the accident had been fatal. Mr. Evans was picked up unconscious beneath the wheels of the car and carried into a drugstore where it was found that he had suffered a broken collar-bone, a broken wrist and severe bruises on the back of his head. Mr. Evans was going around in front of the car, with the intention of boarding it, and had just reached the center of the track, when the car was started suddenly by the motorman, knocking him down on the pavement. The motorman, who is said to be a green hand, turned the power on with great force, and the car shot forward before Mr. Evans realized his danger. A friend and several bystanders, assisted by the conductor and motorman of the car, carried the injured man to the drugstore, but his condition necessitated his removal from there immediately. Mr. Evans was unconscious for two hours, and before a careful examination was made it was thought his skull was fractured. He is now out of danger. Mr. Evans has made several visits to Hillsboro in the interests of the United Railways Company.

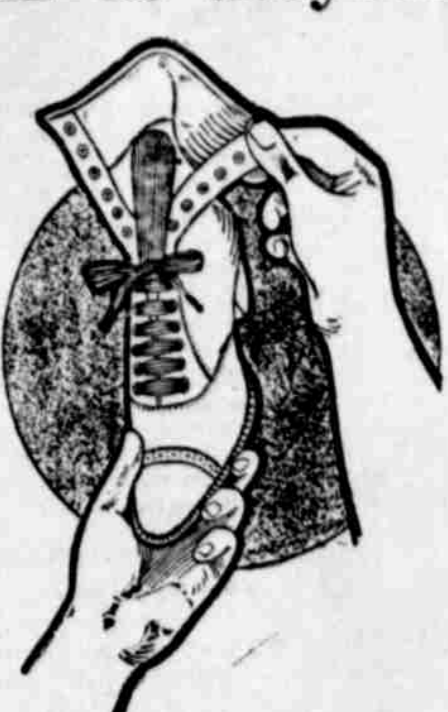
Dance on Saturday, July 28.

Hillsboro's New Saw Mill.
It was announced in these columns two weeks ago, that a large sawmill would be built here this summer. Since that announcement was made an effort has been made by the Board of Trade to have a mill built here, by men who are well-known timbermen and residents of this county. The Hillsboro Board of Trade have again demonstrated that when they want anything they go after it, in a determined manner and this week over \$600 has been raised for the purchase of several acres of land on the corner of Third and Railroad streets, where the mill will be built and in operation inside of sixty days. The machinery and timber will be brought here, as soon as the railroad officials can make arrangements for having the required switch tracks laid.

The members of the new corporation are J. C. Hare, E. M. Ward and Geo. A. Morgan, who have incorporated with a capital stock of \$10,000. Mr. Hare is a successful saw-mill man and well known in this community and is the proprietor of a mill located on the Tualatin river. Mr. Ward owns a mill and is a man of long experience in this line of work. The mill will move the machinery of the mills owned by them here, and make this mill one of the largest in the county, with a capacity of thirty to forty thousand feet per day. The new company have purchased several large tracts of timber along the P. T. & N. railroad and the logs will be shipped here by that company. The success of the new enterprise is assured as the parties interested are experienced men and thoroughly understand the lumber business.
