Hillsboro has a case now in the county court, and if the charges against the husband are true, he should be given an opportunity to tell his story to Judge McBride. The judge has a deep feeling for a man that will strike a woman, and when a wife-beater is brought before him he usually makes business for the sheriff and the post. By all means introduce the man who is said to feed his children on raw fish to Judge McBride. He will give him a Thanksgiving dinner that will take a year to digest.

A letter received by W. R. Hoyt states that a son was born recently to J. E. Kirkwood, of Syracuse, N. Y., Mr. Kirkwood was formerly a student of Pacific University and is a son-in-law of Mr. Hoyt.

The Oregon Condensed Milk Company has been shut down since a week ago Tuesday on account of relinishing furnaces and since that time the milk has been separated and sent to the Hazelwood Creamery in Portland. A couple of local three hings engines have been furnishing the power to run these separators. Orders are away behind and a scarcity of cars keep holding their orders back. The plant will be in operation again this week. F. Shomberg, who has been manager of the factory since it started, tendered his resignation last week. His health has been very poorly, having been confined for the past five or six weeks to his home on account of inflammatory rheumatism. He tells us that he intends to go to California where he thinks he will be much benefited. His son Chas. Schomberg now has the management of the factory.

Last Sunday morning a Japanese named S. Kimatsuki was instantly killed in a landslide on the right-of-way of the Pacific Railway & Navigation Company near Buxton, about twenty miles northeast of this city. Another Jap named K. Ogata, who was caught in the slide of earth, was taken out alive, but lingered only about an hour. Two others, S. Feragi and I. Kase, were seriously injured, the former suffering a fracture of the jaw, and the latter having both legs broken. The bodies of the dead men were brought to Hillsboro and taken to Patterson's undertaking rooms, where a crowd viewed them. Coroner Brown made a thorough examination into the cause of the death and injury of the unfortunate men and found that no blame can be laid to the company. Kimatsuki was caught in the slide and a large amount of earth and rock fell on him, killing him instantly. His remains were not dug out until along in the night. The three injured men were carried on stretchers to the railroad and conveyed to the hospital in Portland. Two others were quite badly injured, but not seriously, and many more were bruised and had narrow escapes. John Kline, who had charge of the work says that on Sunday morning at 11:50 there were three Japs at work in the cut, drilling holes in the rock for the purpose of blasting and the rest were engaged in shoveling and picking, when the landslide occurred, which resulted in the killing of the two, and wounding five others, only three of the injured being seriously hurt, and he saw that all were taken from the slide. K. Ogata died on the way to Buxton, where they were being conveyed with the other seriously injured, and put on the train. He says that there had been no powder used in blasting for three days previous to the accident.

Kimatsuki, was 40 years of age, and had been a soldier in Japan during the war with Russia. He carried his discharge papers, and had two medals for bravery given him by the Japan government. Ogata was 27 or 28 years of age. The unfortunate men were buried at the poor farm near Newton, on Tuesday, a large number of Japanese coming out from Portland to attend the ceremonies.

Whether Portland is copying after Hillsboro or Hillsboro after Portland, is not stated, but on Saturday morning at the opening of Judge Sears' court in the former city, Attorney Henry McGinn stated that District Attorney Manning "is selling his office right and left, everywhere as cordwood," and a few hours later Mr. Manning came back at McGinn in a very pointed and caustic manner. Judge Sears cited both to appear before him, saying they were both in contempt. Mr. McGinn handed the judge a few hot ones from his word tank and Mr. Sears fined him \$25. This seemed less than the lawyer expected and he came back with other hot remarks, until the judge added to the fine until the amount reached \$150, when Mr. McGinn left the court room mad all over. District Attorney Manning apologized to the court, but his apologies were so much worse than the offense made in the court room that day that the judge had to call him down several times, and tell him that he was putting himself in contempt several times over. The wordy war between Attorneys Thos. H. Tongue and M. B. Bump in Justice Bagley's court in this city last Friday evening, during the trial of the chicken case of Sanders vs. Berger, in which the two attorneys came to blows, was not a patching to the scene in Judge Sears' court, though while it lasted was a real warm proposition, and resulted in a three days' sentence for Mr. Bump and a reprimand for Mr. Tongue, both for contempt. Mr. Bump was escorted to the county bastille, but released the next morning. Simmered down, the cause of the trouble was a remark made by Attorney Tongue as to the way Mr. Bump was conducting the examinations of witnesses. The lie was passed and for a few moments things were lively in the court room. Passion on the part of both attorneys caused the trouble, but no serious damage was done to either. The jail sentence of Mr. Bump is looked upon by many as severe, and it is said by those who were in the court room at the time that both attorneys looked for a fine.

For Councilmen—Claude Greear;
John Brown, O. F. Sheldon.
For Recorder—Benton Bowman.
For Treasurer—A. C. Shute.

The following resolution was offered and adopted unanimously:

Resolved, that it is not the object of this caucus to nominate a prohibition ticket or to attempt to carry out prohibition ideas, but we are in favor of electing officers who will enforce existing laws and ordinances, and who will frame such ordinances as will be for the best interests of the people of this city.

Every man on the ticket is well known and well qualified for the office for which he is nominated. The ticket in no way represents the "prohibition" idea in any way, but if the men are elected they will work for the best interests of the entire city. The two tickets are published this week and our readers are asked to look them over carefully and vote for the men they believe will serve the city best.

Drunk, That's All.

Beaverton, Nov. 25, Special.
Considerable prominence was given in the last week's issue of some of the county papers to a story originated by a man by the name of Ensign in regard to the Snyder case and connecting a very estimable lady of this community with this case. The facts of this case are as follows: About four weeks ago a traveling upholsterer dropped into town and began soliciting work. He secured a room at a private house and at a place where the lady was not in the habit of renting rooms, as the published accounts would lead one to believe. After about a week the real nature of the man became apparent and a good big drunk was the result of course. He was assisted to his room by some boys, who also informed the "landlady" of his condition. She at once asked the boys to take him out of the house, which they did. By this time Mr. Ensign's badly muddled brain told him that he wanted to get into the house again and he thereupon proceeded to hunt up an axe, chopped down a screen door and broke into the house. About this time the marshal was sent for and he took charge of our worthy friend until morning. In the morning Ensign's fertile brain concocted the Snyder story connecting this lady with it in retaliation. Now it is hard to see why he did it. This "landlady" has lived in this community probably twenty years and her reputation is such that only her denial of the truth of this story is necessary to convince at least 75 per cent of the people of this community of its utter falsehood.

After collecting in advance what money he could for work that he promised to do Mr. Ensign again traveled. It might possibly be well for the officers to look up his present whereabouts.

A Casual Observer.

A Subject for the Whipping Post.

J. D. Rosclair was up before Judge Goodin Wednesday to show cause why his children should not be taken from him and placed in care of the Boys' and Girls' Aid Society at Portland. If the stories told of the inhuman father and brutal husband are true, a good dose of the whipping post is about what is coming to him. It is claimed that for years he has used his wife in a brutal and cruel way, has made her do a man's work out of doors in all kinds of weather, and has subjected his children to the harshest kind of treatment, not giving them enough to eat or clothing enough to cover their bodies, and to make matters worse, has forbidden his wife to do anything for them. It is said of him that once, after striking his boy in the face and making his nose bleed, he told the lad to swallow the blood as it was good enough eating for him.

Rosclair lives near the old Billing's place on First street. He has a claim about 8 miles northwest of Buxton, but it is encumbered and he has little show of clearing off the indebtedness. He is in poor circumstances, but it is said, he is mostly responsible for the ill luck that is following him. If there is an old horse in the neighborhood that has outlived its usefulness and a candidate for the bonnyard, he manages to become its owner, and by ill care and starvation soon has the animal out of misery and beyond his cruelty. For a living he peddles fish and is well known to almost everyone in the county. His wife and children are in terror whenever he is around and dread to hear his coming.

Mrs. Rosclair is an educated woman, and before marrying him was a school teacher, and she declares if freed from his influences she could make a living for herself and family, but as his wife, she is in constant fear that he will do her bodily harm, and perhaps kill her. Seven children have been born to them, four of whom are living. The baby, 11 months old, died a few weeks ago and it is said the cause of his death was due to neglect of the father. After the child's death Rosclair promised to do better and beat his wife and children no more, but his promises were soon broken. Now Mrs. Rosclair asks the court to protect her from her brute of a husband, that the children be placed in the care of the Home until she is in a position to work and care for them. He has threatened to kill the whole family and himself, it is said, and she asks that something be done to keep him from harming the children and herself.

The case was called at 1 o'clock Wednesday and adjourned until 1 o'clock Friday. The Aid Society is represented by Hon. W. N. Barrett, Mrs. W. E. Thorne and Mrs. R. Waggener, and the defense by Thos. H. Tongue.
