On the Flathead reservation in Montana snow is six inches deep. On Tuesday Western Montana experienced a regular blizzard.

Senator Bourne is "making good" in Washington, and official information is received that all Oregon appointments will have to go through his recommendation. Senator Fulton is regarded at the White House as disposed to oppose the president on paramount issues.

It is now proposed to change the program and instead of sending a lot of young women from McMinnville to the Jamestown exposition dressed as Indians, to uniform them and send them as the "Oregon Girls' Drill Company." This beats the square idea all to pieces, but why not dress the girls up in clothing like their sisters wear at home every day and send them to the fair to represent just what we have in Oregon, the loveliest and best women and girls on earth?

It may not suit the insurance companies, but the opinion of Judge Hunt of San Francisco will be considered a just one by persons who met loss by fire in California a year ago. He has decided that the earthquake clause in insurance policies relieves the companies only when the building is completely destroyed before fire starts, and that when fire destroys a building that has been partially wrecked by the earthquake the company is liable for what the building was worth after being damaged by the shock.

Woodburn Independent: Farming in Oregon paying? Look at the markets and the great promise in that line and quit growling. Hops will be all right, clover seed will be all right, potatoes, onions and other products will be all right. Gaze upon these sales to Fred Dose, commission merchant, know that there are many others like them, and ponder deeply and to the point: Sales of potatoes—P. J. Anderson, ten acres, \$1,043; Martin Bergan, six acres, \$750; Bonney Bros., one and three-quarters acres, \$317. Onions—Hemshere Bros., four acres, \$800. This is the right kind of drafts that make one in the farming business in this section squeeze with an hurrah.

Hillsboro ice cream and confectionary dealers, as well as dealers in most every town in the county, pulled the "lid" off last Sunday and sold cream all day and into the night, thus violating the Sunday closing law. It was done openly, the dealers uniting together to determine if the law is constitutional. Assistant District Attorney Wall notified all business men, excepting meat markets, drug stores, baker shops and literary stable men to close up on Sunday, two weeks ago to obey the law, and the first Sunday after his ultimatum everything was shut up tight as an oyster, the markets closing with the rest. But the ice cream men decided that as Sunday was their real busy day, they would defy the law, and if necessary carry the case from court to court until the matter is settled for good and all. They claim that Sunday is their best day, and if forced to shut up, they might as well go out of business. It is now up to Mr. Wall and the law.

A good many Oregon editors have been telling in the Portland Oregonian their opinion as to whether President Roosevelt will again become a candidate. Almost to a man they believe he should and will. Here in Washington county the republicans, and other men of a different belief politically, are of the opinion that Mr. Roosevelt should be re-elected so that he can complete much important work that he has begun, which would be difficult, if not impossible, for another man to push successfully. His policies are strongly endorsed by the people here, and the position he took in the Harriman controversy has made him friends and in no wise impaired his popularity, but has added to it. We believe that President Roosevelt should succeed himself and his acceptance would mean an election, but we are of the candid opinion that he will not accept the nomination, no matter how much pressure is brought to bear to induce him to do so. Mr. Roosevelt has said several times that under no circumstance would he accept a renomination, and when he says anything he means just what he says. Personally, we should like to have him change his mind, but it is not at all likely that he will. There is one thing sure, however, he will name the next candidate for president of the United States on the republican ticket.

Woman's Home Companion for May

The possibility that a defunct cat should have nine ghosts probably never occurred to any writer until Ella Parker Butler contributed his very funny short story, "The Chromatic Ghosts of Thomas," to the May Woman's Home Companion. The story certainly will march down the aisles of fame arm in arm with "Pigs in Pigs" by the same author. Mr. Butler's story had plenty of good company. In the same number of the Woman's Home Companion are three other exceedingly clever short stories: "The Wall of the World," by Herbert D. Ward; "The Madness of Watkins," by Henry M. Hyde, and "Their Innocent Diversions," by Jean Webster.

Among the special articles are "The Progress of Women in the Last Fifty Years," by Charlotte Perkins Gilman; "Shopping in London," by Carolyn Wells; "The Home Builders—Planning the House," by Charles Edward Hooper; and "Europe on Two Dollars a Day," by Esther Brook. Lovers of music will be delighted with the double-page contribution "Fragrance," a new song by Victor Herbert. Dr. Edward Everett Hale, who writes an editorial page every month, tells about a memorable visit to Mount Vernon. The department devoted to the child labor campaign contains an important article on "Child Labor and Education in Southern Cotton Mills," by A. J. McKelway, assistant secretary of the National Child Labor Committee. Mr. McKelway reproduces an agreement made between parents and mill owners, in which the parents promise that their "children above twelve years of age shall work in the mill." Grace Margaret Gould describes the latest fads in gowns and frocks; Evelyn Parsons contributes new ideas for summer needlework, and Fannie Merritt Farmer describes emergency dishes in her monthly cooking lesson. In the pages for children Dan Beard tells the "Sons of Daniel Boone" how to build play forts, and Aunt Janet sends a message to the members of her "Club of Clubs." The May number of this popular magazine is illustrated in colors—an important departure for magazines of its size.

In regard to spray poisoning a dispatch says: "A case that is attracting considerable attention among medical men at Hood River, is that of T. B. Young, of Odell, who is in a critical condition from spray poisoning. Young, who was recently engaged in handling the mixture, is thought to have absorbed the poison into his body by being too careless. This is the first case of its kind here and is being watched with considerable interest. He is reported somewhat better, but his condition is still regarded as very serious."—Ex.
