Melvine Enoch, a photographer of Washington, a brother of J. W. Enoch of Reedville, is visiting at the latter's home. The brothers had not met in twenty-two years, and naturally they have been having a happy visit. The bulk of the prune crop of Oregon was sold at an average price of about 41 cents a pound. Now the price is up to 51 cents. Somewhere between the grower and the consumer a clear profit of 1 cent a pound or \$20 a ton, has been made without any expenditure whatever. But the grower need not worry about that. He thought he was getting a good price when he contracted, and if he sold too soon he must take his medicine and get what consolation he can from the probability that big profits for the dealers this year will make them ready buyers next year.—The Oregonian.

On Monday last at about 6 o'clock in the evening Mrs. R. C. Radcliffe, of Scholls, went to call her husband to supper and found him lying on the ground, dead. Coroner Brown was notified and after hearing the circumstances, decided that death was caused by a stroke of paralysis brought on by overheating, and that an inquest was not necessary. Mr. Radcliffe was in the yard splitting wood and about 5 o'clock his wife told him he ought not to work out in the hot sun. He said he wanted to finish up the job when he would stop. He was a prominent resident of Scholls and about 65 years of age. It is said he suffered a stroke of paralysis several years ago.

Andrew Hoerth, of Seasideville, east of Cedar Mills, who is charged with incest, was up before Justice Bagley Wednesday. Testimony was taken for the state, but the defense declined to submit any evidence at this hearing, and the defendant was held over to the circuit court in bonds of \$1,000. The evidence against the unnatural father is very strong. The daughter is only 15 years of age.

Dr. Woods has broken ground for his new brick block on Main street. THE CELEBRATION.

Fully 8,000 People in Town and Nobody Disappointed.

Never in the history of Washington county has there been a larger or better celebration than that of July 4th, 1907.

As early as 8 o'clock in the morning people commenced arriving from the country and by 9 o'clock several thousands had arrived. The P. R. & N. Portland train brought many more, which were landed at the park entrance. The 9:03 east bound train was packed to the guards with joyous crowds from Cornelius, Forest Grove, Gaston, Dilley and other points west, and by 10 o'clock the streets were filled with visitors waiting for the parade which moved along Main street, down Second and to the Park at about 10:30. The parade, while not very large, was attractive, unique and attracted a great deal of attention and was a source of much joy to the "kids" and older people as well. Ahead of the procession was James C. Lamkin carrying the American flag which for twenty-five successive Fourth of July celebrations has floated at the head of some demonstration, either here or some neighboring town, and Mr. Lamkin has always been its bearer. The history of that banner is worth recording here. Something over twenty-five years ago Mr. Lamkin went before the county commissioners and asked for money to buy a flag to be used in the celebration of the Fourth of July, but his request was turned down on the plea that there was no money on hand that could be used for that purpose and besides the county was too poor to purchase such a flag as he wanted. Anyone acquainted with Mr. Lamkin knows that a little discouragement like that didn't dampen his patriotism in the least for he is an old veteran, has heard the shriek of shot and shell and has had his clothing saturated with the smell of gunpowder. So he only bowed his heartfelt thanks to a body of men whose patriotism was small that they could not afford a flag and went away. He hitched his horse to a buggy and drove to Portland and with his own money bought the flag that for twenty-five years has been in service at every celebration. This was its twenty-fifth anniversary and as the bearer walked at the head of the procession his thoughts traveled back to the first demonstration a quarter of a century ago and he felt proud and grateful that he was permitted to carry aloft the stars and stripes his own money had procured and which he had yearied in the breeze since that time. Following Mr. Lamkin came the processionists about the following order:

Newberg band.

Speaker of the day, Hon. B. B. Beekman.

Mayor Dennis and city officials.

Grand Army of the Republic.

Goddess of Liberty float.

Float of the Hillsboro Lumber Co.

Float of State.

Hillsboro band.

Citizens in carriages and on foot.

It is estimated that there were gathered at the park in the neighborhood of 10,000 people, but it is a safe guess to place the crowd at 8,000, nearly all of whom were Washington county people. It is thought that about 100 came from Portland.

The exercises at the grounds came off promptly and without a hitch. The program was opened by an address of welcome by Mayor Dennis, followed by an invocation by Rev. Gilpatrick. The reading of the Declaration of Independence was by Frank Peters and Hon. B. B. Beekman then delivered a stirring and patriotic address, which was listened to with marked attention. Then followed music by both bands, and a adjournment for dinner.

The sports in the afternoon consisted of a ball game between Cornelius and Banks, in which the latter spread it all over the Cornelius boys, though they put up a good game and up to the fourth inning was no one's game.

At about 3 o'clock the balloon ascension was made and a prettier sight was never seen anywhere. The balloon was cut loose and ascended almost straight up for a half or three-quarters of a mile, when the aeronaut made his drop and came down within a quarter of a mile of where the start was made, while about after about went up from thousands of throats. The report had gained circulation that the balloon would not go up, but this was a mistake which arose because of a disagreement between Frank Miller, the owner of the balloon, and the committee. Everything was settled at last and the people saw as fine an ascension as is witnessed anywhere, and everybody was well pleased.

The sports came on time and attracted a big crowd. Following is the official score:

Rony Race, Oregon Lady, Will Cornelius, first; Trisix G. Smith, second; D. C. Sain, distanced.

Buggy Race—C. F. Wilson and G. Green, Maud, first; D. B. Emrick, second.

Saddle Horse, Free for All—J. W. McCrum's Sports, first; W. Cornelius, Oregon Lady, second; G. Wolchkegel, Dist. dist; C. H. Olsen, Chief, dist.

Foot Race, 100 Yards—Roy Heater, first; Walter Robinson, second; James Broderick, third; Harry Batebelor, fourth.

In the bronco race, D. B. Emrick won the \$25, and Roy Taylor captured the greased pig.

The weather throughout the day was ideal and everybody seemed pleased with the celebration, and Hillsboro is glad that she made good and that the 10,000 visitors went home satisfied that all that had been promised had been performed. The fireworks at night were fine and an immense crowd waited to see the finish. Perfect order was maintained and not a disturbance occurred to mar the best and largest attended celebration ever given in Washington county. After paying all expenses, the

committee will still have some money left, which will go toward improving the park.

FOURTH OF JULY AFTERMATH.

The balloon brought out a lot of rub-benicks.

The merry-go-round was one of the principal attractions on the grounds and was crowded from early in the morning until steam was shut off along after midnight. It is said that over \$5,000 was taken in at the wheel.

The dance pavilion was another money-maker and a source of much pleasure. The high wind of the day before tore off the overhead canvase and made dancing in the sun a little inconvenient and decidedly warm, but in the afternoon the covering was partially replaced and until 2 o'clock in the morning the merry dance went gaily on, the floor being crowded to the limit every minute. It looked decidedly bad for the success of the pavilion on the 3rd, as wind and rain put a damper on all sports, but not a drop of rain fell during the 4th, which changed the looks of things and Mr. Boscow "made good" and some more. Everything was orderly and everybody satisfied.

The illuminations of Mount Hood and Mount St. Helens were plainly visible from Hillsboro and were witnessed by quite a number of our citizens. The torch was applied at 11 o'clock sharp and from here looked like a huge ball of fire. The illumination lasted precisely five minutes. A similar illumination was made on Mount Adams, but was witnessed by but a few from here.

The following appeared in a county paper last week and is without foundation so far as "the blazing sun" is concerned, for there was plenty of shade in the park and many of the trees are twenty and thirty feet high:

The celebration grounds are crowded with stands—an exceptionally large number, and if the different vendors of Fourth goods do not come out in the red ink column of the ledger it will be strange indeed. They are out in the blazing sun and fringed with small trees twelve or fifteen feet high, which would, but can not lend much shade to the mirth seekers.

There were but three accidents during the day. One was that of a lad who was backed into by a horse, but not badly injured. Another that of a lady who persisted in standing with her baby buggy in line with the catcher at the ball game, though asked several times to move to safer quarters, but she refused saying that she would stay where she chose to. She did, and a foul ball whacked her on the head and her retreat to safer quarters was quick and very sensible. Her eye was blackened, but she was otherwise uninjured. The third accident and the only one of a serious nature happened to Ed. Groat, of Fresno, Calif., who is visiting his father at Scholls Ferry. He was hitching up his team preparatory to going home, when one of the horses became frightened at some firecrackers and kicked Mr. Groat squarely in the face, smashing his nose flat, fracturing his skull, knocking one eye so it bulged out and otherwise disfiguring his face. He was placed in the hands of Dr. Linklater, who had him removed to the hotel where his wounds were properly dressed, and early this week he was taken to the home of his father at Scholls. Though in a serious condition, he will recover, but will be more or less disfigured for life.

To the credit of Hillsboro and the thousands of people from all parts of Washington county and many from Portland, but one drunken man was seen on the streets during the day. Not an arrest was made and the few people who did "jolly up" just a little for the occasion caused the police no trouble. Hillsboro is a licensed town and the three saloons dispensed liquid refreshments in abundance, but the people kept their heads. The fashion of getting gloriously drunk at Fourth of July celebrations seems to be going out of fashion, in this section of Oregon at least. At any rate there was none of it visible on the streets in this city last Thursday.

The hotels were crowded to overflowing and a room could not be had for love or money after 9 o'clock in the morning. Another good argument in favor of a new and up-to-date hotel.

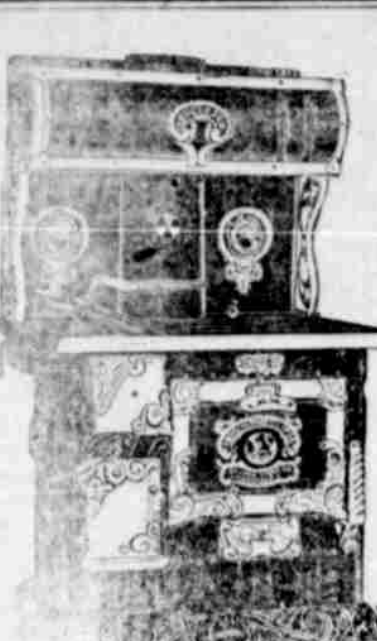
The baker shops ran out of bread-stuffs and cakes shortly after noon, when crackers and cheese became the chief and most popular articles of diet.

No man is entitled to more credit for the complete success of the celebration than is Mayor Dennis. He worked early and late and seemed to take as much interest in the matter as though it was a personal thing with him. He was everywhere and seeing to everything and when midnight came he was still looking about to see if there was anything lacking to make the thousands of guests happy. It will take him a month to rest up, but he is well pleased with the outcome.

And the Park committee are also entitled to a great deal of praise for their work. Two weeks before the great event things looked dismal enough out on the grounds. But every man in the bunch took hold and transformed the Park from a barren piece of ground, covered with stumps, roots and underbrush, to a beauty spot, and the work was practically all done in two weeks. Money was spent and lots of hard work performed and the committee are glad now that they turned in with a will.

When the city bought that Park they did this city more good than any other one thing that has happened in many a month.

Said a gentleman the next day after the Fourth: "Things will be quiet now for a few weeks, but we had a rip, roaring good old Fourth, didn't we?" And that's about the way everybody looks at it.
