Fresh Lads from Portland.

While celebrating a football victory at Forest Grove last Saturday, a number of high school students from Portland barely missed spending a night in the Washington county jail. The trouble occurred when a large crowd of students invaded a confectionery store belonging to Oscar Baldwin and began helping themselves to candy, fruit, cigars and other perishable goods.

In the absence of Mr. Baldwin, who was attending the street fair at Hillsboro, Mrs. Baldwin was in charge of the store. Unable

to intercept the boys, who had left before the pilfered wares were missed, she telephoned to her husband at Hillsboro, who met the train with the sheriff and demanded payment for the stolen goods. It was necessary to detain all who might possibly be implicated and a general invitation to the Portland contingent to vacate the train pending a settlement of the claim was performance accepted.

Five boys were charged with the theft and were asked to come down with \$3.50, the sum necessary to cover the loss as reported by Mrs. Baldwin. The five implicated youths from Portland had only \$1.50, but by scraping the sum was found in the crowd and the boys were allowed to go.

But meanwhile the train had passed on, leaving the boys marooned at Hillsboro until Sunday morning.

Death of Elial Brooks.

Emory Elial Brooks, was born in the town of Pembroke, Genesee county, New York, October 6, 1828, and died at Scholls, this county, September 21, 1907, aged 78 years, 11 months and 15 days. He moved to Michigan with his parents when he was 8 years old, receiving his education in a common district school. He helped his father clear up 120 acres of land in the county of Lenawee, town of Rome, where they made their home.

In 1852 he crossed the plains, to California, being six months on the way. He remained in California about two and a half years prospecting for gold and doing other work connected with mining. Wages at that time were high and so was everything else. When he had accumulated about \$2,000, which was quite a large sum in those days, he returned home by the way of the Isthmus of Panama and bought a tract of land consisting of eighty acres in the neighborhood in which he formerly lived.

In 1856 he married Miss Martha J. Taylor, and to this union were born five children, all of whom are now living except one. They are N. A. Brooks and D. E. Brooks of Goldendale, Wash.; C. H. Brooks of Scholls, and Mrs. Jennie Griffin of Dinubia, Calif. His wife died in March, 1869, and in 1870 he married Miss Almira Smith. To this union were born three children, E. M. Brooks of Oakland, Ore.; Mrs. Orrie Lawrence, now deceased, and Rollin H. Brooks of Scholls. In 1874 he crossed the plains again with his family, but this time instead of walking most of the way, he came over the Union Pacific to San Francisco and thence by boat to Portland, soon after purchasing 240 acres of mostly uncultivated land near Scholls Ferry. He lived to make a pleasant place out of the timbered land purchased and see his children grow up around him, giving each one up on becoming of age a small tract of land or its equivalent in money to begin the struggle of life with. He had the respect of his neighbors and was always ready to assist in making public improvements in the neighborhood.
