Dr. Wood sends in his report of the vital statistics for Washington county for the month of February, as follows: Marriages, 9; births, 23, 10 males, 13 females; deaths 14, 7 males, 7 females. Contagious diseases reported 8; measles, 5; diphtheria, 3.

W. H. Holcomb, at one time general manager of the Oregon Railway & Navigation company, died at Chicago last Sunday. In 1888 he became vice-president of the Union Pacific and in 1892 was selected as general manager of transportation of the World's Columbian exposition at Chicago. Mr. Holcomb was well known in railroad circles in this section.

Last Friday C. Rhoades received from Kent, England, directly from Cooke & Sons, the breeders of the famous Buff Orpington hens, a full-blood rooster. He has also received from Scotch Plains, N. J., two pullets of the same breed. He proposes to see what can be done with the pure blood stock and next year will be able to furnish thoroughbred birds to poultry fanciers.

A dispatch from Washington, D. C., says the forest service has recommended that the number of cattle and horses allowed to graze upon the Blue Mountains (W) National Forest in the State of Oregon, during the season 1908, be increased from 16,000 to 17,900 head and the number of sheep from 150,000 to 152,500 head. This forest has recently been divided into three administrative units, and the increase in the number of head of stock to graze on the range this year was made to permit an equitable adjustment among the former users of the forest.

Earl E. Fisher, mayor of Beaverton, announces in The Independent this week that he is a candidate on the republican ticket for the nomination of state senator for this district. He also gives the platform on which he proposes to run and the measures he will work for if elected. Mr. Fisher is a young man of energy, a sound republican and fully competent to hold the position he seeks. He states his position plainly that the voters may know where to find him. He will make a vigorous canvas and if nominated will be elected.

The play given at the Crescent Theatre next Monday night by the dramatic students of Pacific University will not be an amateurish affair. Many of the characters are taken by students that made "The Bridge of the Gods" famous at the Heilig Theatre in Portland last spring. Miss Heidel, the talented young lady from this city who was so successful in the character of Wallulah last year, and Prof. F. W. Orr, of Pacific University, will appear in a very laughable sketch. It is evident that the young man is hardly responsible for his actions, hence the light sentence for so serious an offense.

Fire in the rubber store of the Pacific Rubber Co., on First street, Portland, last Wednesday morning, did \$30,000 damage. Loss to the stock was \$60,000, and to the building, \$20,000, both covered by insurance.

An Honored Pioneer Passes Away.

George Dorsey was born in Pennsylvania on January 13, 1830. He was of Scotch ancestry, his father being a native of Scotland. He moved with his parents to Ohio when a year old, and lived near Findley until 1852, when he crossed the plains to Oregon, driving an ox team, and settled in Yamhill county. On Christmas day, 1856, he was married to Adaline Vaughn, a native of Indiana, who came to Oregon with her parents in 1846. They made their home in and near Dayton until 1861, when he bought a farm near town, where he lived until the time of his death, with the exception of the three years they lived in Dayton. To this union were born eight children, four of whom are living. J. P. Dorsey, Mrs. Fannie Belknap, wife of Rev. L. F. Belknap of Hillsboro, A. B. Dorsey of Waterville, Wash., and Mrs. Hattie E. Perry of Dayton. His wife preceded him three years ago to the shore. He was a man of noble character, highly honored and much beloved in the neighborhood where he had lived for half a century. He was a wise counselor, a promoter of peace and harmony; and a friend to the poor, many young men having been given a start in life by his generosity. He was a great lover of home and provided bountifully for his family, affording them all the modern conveniences. His was always considered the model farm. He leaves a large circle of relatives and friends who will hold him in grateful remembrance.
