Hillsboro's Inventor.

A representative of THE ARGUS called on W. H. Rucker recently and was shown a model for a mechanical contrivance of which that gentleman is the inventor. It is a water motor fan and when perfected will undoubtedly find large sales. It is so arranged that by attaching a water hose or pipe and turning on the water the machine turns a set of fans which throws out a current of air cooled by the waters. It can conveniently be placed on a parlor, dining or kitchen table, and when used in the latter capacity, a sink attached can be used as a refrigerator. Mr. Rucker has secured letters patent for his model, and now has papers filed in England for patent there. He is now perfecting it to considerable extent. The model shows evidence of neat mechanical skill, and was made by Mr. Benson, our local foundryman, under direction of Mr. Rucker. It is proof positive that the inventor has peculiar inventive ability and there is no reason why he should not profit by his work.

School Meeting.

COMMUNICATED.
EDITOR THE ARGUS:
Almost everyone admits that more money is needed. The question is what kind of money would be best suited for a medium of exchange. Greenbacks, silver certificates and treasury notes can be used by speculators to drain the gold out of the treasury is not a good money for the common people. It looks like any money or paper based on gold, something of which the government has none but has to borrow, cannot be considered sound money as it may at any time be withdrawn from circulation and presented to the treasurer for redemption, and if gold is not on hand more bonds have to be sold. Every reading man knows that the government has not the gold to redeem its notes and greenbacks but has to depend on its credit. Why not base the notes and greenbacks on the government's credit in the first place, or on something the government has.
National bank notes cannot be considered good money for the people as it gives to the bankers the power of regulating the value of the money that people must have to use. The government ONLY should be able to regulate the value of money. It is time the government should stop making money that can be used by speculators to bankrupt the treasury and finally the government.
Continuous money should be issued by the government and loaned direct to the people at a reasonable rate of interest. Gold silver and paper money could be made to be redeemed when worn out only to be re-issued.
