A DISASTROUS BLAZE

Forest Grove Suffers a Very Severe Loss Sunday Morning Last.

WAREHOUSE AND MILL DESTROYED

And the Loss Goes Way up in 'The Thousand'—Express Office in This City Robbed in Broad Daylight—M. A. Young's Children Cared For—Our Pioneer's Visit Port. and "Reminiscence" on Ye "Olden Days."

Expensive Blaze.

Early Sunday morning the residents of Forest Grove were awakened by an alarm of fire, coming from the direction of the depot. It was discovered that the warehouse owned by A. L. McLeod, and the Forest Grove Flouring Mills were ablaze. Being so far from the heart of the city, the fire had so advanced by the time the fire department arrived, that little could be done, and the structures were soon in ashes. It is reported that about 5000 bushels of wheat were stored in the mill, and that the warehouse should have contained in the neighborhood of 15,000 bushels. The wheat pile in the ashes of the mill ruins was quite large, but a conservative estimate of that in the ashes of the warehouse is placed at perhaps 5 or 6 hundred. McLeod, the owner of the warehouse was in eastern Oregon at the time of the conflagration, and those who had wheat stored there are naturally very anxious to find just what the true status of the case is. The flames first started in the warehouse and afterward communicated to the mill. So far as is known but one man who had wheat stored in the warehouse carried insurance. Messrs Breeden, Brown and Albert the owners of the mill had but recently newly equipped their establishment and as they had but \$2800 insurance, it is a severe blow, the mill being perhaps worth six or seven thousand dollars. Besides the building and wheat, there were \$400 worth of new sacks destroyed, and 50 bbl. of flour.

It is said on reliable authority that T. G. Todd, county commissioner, had in McLeod's warehouse, over 2000 bushels of wheat, besides a few bushels of oats. The loss of both buildings and grain and machinery contained therein, is a severe one to the college town, and the fire aggregates away up in the thousands.

Robbery in the City.

Last Saturday evening the store of L. L. Williams was robbed of about \$90.00. It is said that the money was in the till when Mr. Williams went to supper. Upon coming back to the store he entered, and with him, Geo. Ireland, who is an old resident of this place. Mr. Williams stepped out to procure some kindling and upon returning Mr. Ireland had departed. Shortly thereafter, having occasion to go to the register to get some change, he found that the money had disappeared. A warrant was sworn out and the premises of Mr. Ireland were searched and he was brought before Justice J. I. Knight who released the prisoner on bail. No money was found on his person or on his premises, and there are many who believe him guiltless of the charge. Ireland has had his request for hearing deferred, until Friday morning, when the matter will be tried before Justice Knight.

Smith's Case.

The children of Mrs. Young, who lived with the man Smith, near Beaverton, have been taken to the Boys' and Girls' Aid Society at Portland, where the officials are endeavoring to procure proper homes. It is said that the house in which they were living was a pitiful scene of squalor. The necessary requisition papers are on the way from California to take the man and woman back although the woman denies having anything to do with the crime.

Oregon Pioneers.

The Oregon Pioneer Association had a great time at Portland last week. Hoary headed pioneers from all points of the state met and reviewed olden times, and again lived over their youth. Next year, perhaps, some that were present will be sleeping the sleep of the just, and each year the old landmarks grow less to number. Hillsboro was represented by J. S. Griffin, who came here in '49 and Henry Wehrung, a '52 comer. Almon Hill, '43 a resident of Gaston, made an address at the campfire. Others from this county were: J. C. Connell and B. C. Her, of Sherwood; '52; Isaac Ball, Tualatin; '52; W. S. Scholls, Scholls Ferry; '49; Ira E. Purdin, Forest Grove; '54, and Thomas Cox, Forest Grove, '52.

Teachers Institute

Washington County's delegation of school Ma'ams is in the city in a goodly number attendant upon

the Teachers' Institute which convened today and which will continue until Saturday evening. A very interesting session is promised and these annual meetings are productive of much good. Prominent teachers will take part in the program. Full particulars will be given next week.

The Chautauqua Association intends leaving no stone unturned to make their meet at Gladstone Park, near Oregon City, in July, a great success. Talented men will address the concourse, appropriate games and amusements will be held and everything possible has been done to further the comfort and pleasure of those attending. Col. R. A. Miller and Mrs. C. H. Dye have labored unceasingly to this end, and Oregon City should be proud of the efforts of these two of their townspeople. Railroad rates on S. P. for one and one-third rate have been procured. Rev. F. W. Gunsaulus, of Chicago, and other divines and educationalists will be there, and on one of the days, the Supreme court of Oregon will be in attendance.

Severe Accident.

While Jos. Hickenbottom, who lives near Shady Brook was riding on a load of hay the other day, in some manner the wagon upset, throwing him to the ground, breaking two of his ribs and otherwise severely bruising him. A physician from this city dressed his wounds and he will be alright in several weeks.
