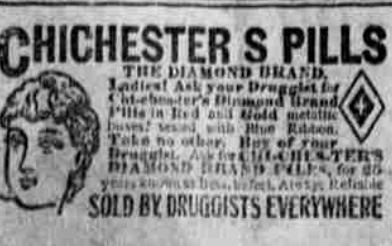
VANCOUVER CHILDREN DIE FROM PTOMAIN POISONING

CRAMPS LOW BIDDER FOR NEW SUBMARINES

Washington, Oct. 6.—The Cramps company of Philadelphia was the lowest bidder today on torpedo boat destroyers numbers 69 to 74. Their offers were \$852,000 each for two and \$842,000 each for three. Other bidders included the Union Iron works of San Francisco, which bid \$915,000 for one boat, and the Seattle Construction & Dry Dock company, \$885,000 for one and \$870,000 for two. The specifications call for delivery at Mare Island and that all the vessels must be finished within twenty months.

WANT STATE OPERATION OF THE CLIFTON MINES

Tucson, Ariz., Oct. 6.—The state federation of labor, in convention here today, considered a resolution calling on Governor Hunt to take over the Clifton mines and operate them. It is probable the resolution will be adopted.

The Applan Way. The famous Applan way was constructed by digging two parallel trenches, three feet in depth, at the bottom of which were placed two layers of flat stones in mortar, upon which a layer of cobblestones was placed, also laid in mortar. Then came a course of pebbles in concrete, over which were placed large, flat blocks of smooth lava well joined together, forming an even, uniform surface. It was primarily a military road and extended from Rome to Brundisium, a distance of 350 miles. So perfect was the construction of this celebrated road that it still exists in places as good as ever, notwithstanding it was made more than twenty centuries ago.

COURT APPOINTS MRS. SPALDING TO ADMINISTER ESTATE

San Diego, Oct. 6.—Death bed scenes of the late A. G. Spalding, "father of baseball" and one-time candidate for the United States senate, which occurred, by strange coincidence at the ninth hour on the ninth day of the ninth month of the present year, were described by his widow, Elizabeth Churchill Spalding, on the witness stand in Judge Guy's court here today, when she asked to be appointed administratrix of the estate. Pale, and admittedly worn from the strain of the past few weeks, Mrs. Spalding protested against being questioned on subjects so painful at this time, but she was forced to tell who was present at the hour the famous sporting goods man died within the walls of the Theosophical homestead at Point Loma.

At the conclusion of her testimony, Mrs. Spalding was appointed special administratrix of the estate under bond of \$50,000. The estate is worth, according to the testimony presented by the widow, less than \$1,000,000, although Keith Spalding, the son and contestant, will endeavor to prove that it is worth over \$2,000,000.

Under cross examination by Attorney Barrett, acting for Keith Spalding, Mrs. Spalding said that at the time of Spalding's death his valet and Dr. Woods, a physician, were with him.

Keith Spalding's attorneys are today preparing to contest the will, which left the bulk of the estate to Mrs. Spalding. Young Spalding refused to discuss the case today.

AGAIN POSTPONE TRIAL OF PORTER CHARLTON AT COMO

Como, Italy, Oct. 6.—Nervous and depressed, Porter Charlton, youthful slayer of his wife, the handsome Mary Scott Castle, of California, is back today in his cell. His trial for murder has been adjourned to October 18 upon request of his new counsel, Midhepe Picardi, who asked for time to study the records. With lips twitching, Charlton rattled the bars of the prisoners' iron cage in the courtroom and begged that the case be not postponed.

The wearisome preliminaries were disposed of yesterday. An Italian attorney harangued the court with a long plea for damages for insult, a Russian, falsely accused and imprisoned after Mrs. Charlton's battered body was taken from the murder trunk fished out of Lake Como. Still another attorney asked for damages for Mrs. Legnazzi, owner of the Charlton honeymoon villa, in which Charlton hammered his handsome bride to death. He declared the place has gained the reputation of being "haunted" since the tragedy and that no tourists will rent it. Both claims were dismissed, however.

Beethoven's Last Days.

Beethoven had troubles besides the scourge of deafness. Throughout his life the conduct of his brothers irked and grieved him, and when on the death of one of them he adopted his orphaned son, his nephew's outrageous conduct broke his heart. Then he felt the sting of poverty. Dying, he would have lacked the very necessities of a waning life had it not been for the Philharmonic Society of England. The society has never boasted of the fact, but a fact it is that a douceur of £100 sent by it to Beethoven at his last gasp made death less a martyrdom to the famous musician than it otherwise would have been.—London Graphic.

ACROSS THE PACIFIC.

Influence of the "Great Circle" on the Journey to Manila. If you wanted to go from the Panama canal to Yokohama which of these two would be the shorter route? First, across the ocean to Hawaii and from there to Yokohama, or second, up along the coast to San Francisco and then directly across the Pacific to Asia? Nearly everybody would answer in favor of the Hawaiian route. But the navigators tell us the journey is 200 miles shorter by way of San Francisco. The "great circle" does it. Its influence on distance sends ships from San Francisco to Manila by way of the Aleutian Islands. Actually our vessels would go much farther north than they do but for the discouragement of the United States hydrographic bureau at Washington, which advises a central route, more than 200 miles longer than the great circle, in order to escape the fogs and lee of the far north.

The Hawaiian islands are frequently described as "the crossroads of the Pacific." Their people are naturally looking forward to wonderful commercial development. They will doubtless enjoy substantial progress as a commercial center because many conditions in ocean currents and in prevailing winds and in fuel costs favor Honolulu as a way station route. But it is well to remember that these islands were planted a little too near the equator to be a crossroads of the north Pacific.—Boston Herald.

Wonderful Names.

The seventeenth century jurymen had one disadvantage to contend with from which his successor is happily free. He was frequently burdened with an intolerable name. James Broome in his "Travels Over England, Scotland and Wales," a work published in 1700, gives a copy of a "Jury Return made at Rye, Sussex, in the late Rebellionous, Troublesome Times." Here are the names: "Stand fast on high Siringer of Crowhurst, Earth Adams of Warbleton, Killin Plimpe of Witham, Graceful Harding of Lewes, Weep not Billing of the same, Be Faithful Joiner of Britling, Fly Debate Roberts of the same, Fight the good Fight of Faith White of Emses, Return Spelman of Watling, Meek Brewer of Oakham, More Fruit Fowler of East Hodyly, Hope for Bending of the same."—London Chronicle.

He Saved the Patent Office.

This is the patent office— a depository of the ingenuity and inventions of the American nation in which the whole civilized world is interested. Would you destroy it?
