Preliminary examination of prisoners can be abolished if he shows a disposition to plead guilty. Under such an arrangement a prisoner desiring to plead guilty can go directly to the superior court, enter his plea and start serving his sentence immediately.

It has been pointed out that such a measure would speed up the handling of many cases and would work to the interests of the prisoners, many of whom are now compelled to remain in jail several weeks before being given a hearing.

The measure, it is claimed, will also result in great financial saving to the state, particularly in witness fees, cost of stenographic transcribing and other court costs.

District Attorney Thomas Lee Woolwine, while talking before a luncheon of the commission recently assured the full support of his office to such a movement.

Enthusiastic endorsement of the crime commission and its work so far has been received from all parts of the state, particularly commending the movement to do away with the preliminary hearing.

Among those who have endorsed the movement are 167 state newspapers, virtually every civic, commercial and social organization in Los Angeles, Oakland, Berkeley, San Francisco and the city councils and chambers of commerce in a score of other California cities.

OBITUARY

Clifford Smith

Clifford Smith was born near La Cross, Wisconsin, May 22, 1862. Died at his home at Rogue River, Oregon, April 3, 1923. At the age of 11 years he left Wisconsin for Missouri with his parents, spending four years there. He crossed the plains with his parents in 1877 and settled on Footh Creek, Oregon, living there five years and at Grants Pass four years. During the four years spent in Grants Pass, he became a member of the Odd Fellows lodge. He was a charter member of the Odd Fellows lodge at Silver Lake and was transferred to the same order at Lakeview, Oregon.

In the spring of 1884, he left for Lake county, Oregon, and spent several years driving stage from Paisley to Lakeview. He was married to Lydia Ann Partin, April 14, 1897, and to this union one child was born. He was engaged in stock raising at Summer Lake and Silver Lake for 14 years. In 1911 he disposed of his property at Silver Lake and settled at New Pine Creek, Oregon, in July of the same year, at which place he engaged in farming and fruit growing for nine years.

He united with the First Baptist church of Goose Lake Valley, September 3, 1917, and had been a faithful Christian ever since. He came to Grants Pass August 21, 1922, and in September 25, 1922, settled at Rogue River, Oregon. He leaves to mourn his death, a wife, a daughter, Mrs. Arlie Thompson and her two daughters, Erma and Arlene Thompson; four step-sons, George William, Roy and Mark Partin; two brothers, Ora Smith of Kerby, Oregon, and Fred Smith of Marshfield, Oregon; and three sisters, Mrs. Carrie Fry, of Carson, Washington; Mrs. Emma Harbison, of Corvallis, Oregon, and Mrs. Hattie Shogren, of Alecta, Oregon.
