Anderson will receive the first of 12 installments of \$5,000 toward his loans in October. As long as Anderson verifies he's still working in a rural county such as Baker, the Health Care Provider Incentive Program will send him the funds every three months for the next three years, the length of the term working in the county required to benefit from this program.

"In Oregon, more than half of our state is designated as having a health professional shortage, covering more than 40 percent of our population," Marc Overbeck, director for the Oregon Health Authority's Primary Care Office, said

in a press release. "These incentives attract more providers to Oregon and help keep providers in the communities that need them the most."

Despite moving around a lot growing up and living in six different states, Anderson began his career of seven years in Baker City after attending high school in Pendleton.

"My classmate was doing her (medical) rotation in Baker. She told me about Baker, and I got talking with Dr. Schott," he said. "It would be a very big surprise if I left."

Anderson is one of two healthcare providers in Eastern Oregon to benefit from this round of the program and one of two PAs.

"I'm blessed and lucky to have a program to have someone pay me to work in the community my wife and I want to stay in until I retire," he said. "My wife would be upset if I came home and said we need to move."

While he said most PAs prefer the fast-paced, higher paying city or specialty job, Anderson said working in family practice in a rural town offers him more autonomy and more opportunities in his work as opposed to being attached to a doctor.

"It's difficult to recruit out here," he said. "You have to want to be out here."

In three years, when this program ends for Anderson, he said he plans to apply for another federal loan program, the Public Service Loan Forgiveness Program, that will forgive the remainder of loans for government or nonprofit employees after 10 years of making qualifying payments. In three years, he will have worked for the St. Luke's clinic for 10 years.

"If someone wants to pay off my loans, I'm doing what I love being where I love, it means a lot less stress," he said.

The Healthcare Provider Incentive Program is administered by the Office of Rural Health at OHSU and has four more award periods this year, including one that closes Aug. 3.

Myldred Perrine

Sumpter Valley

Myldred R. Perrine, 94, of Sumpter Valley, died on July 16, 2018, at Spirit Lake, Idaho.

Her funeral will be Saturday, Aug. 11 at 10 a.m. at the McEwen Bible Fellowship, 36943 Denny Creek Road, Baker City. Interment will follow the funeral at the Sumpter Cemetery, where she will be laid to rest next to her husband, Clyde.

Milly was born at her Aunt Ethel's home in Limon, Colorado, while the family was on vacation there. Her parents, Edwin G. and Margaret M. (Lewis) Gothberg, and older brother Edd lived nine miles west of Casper, Wyoming, on a huge sheep/cattle ranch. Growing-up years were spent in Denver, Los Angeles, Berkley/Oakland and ending up in San Francisco. She attended John Muir and Laguna Honda grammar schools and graduated from Polytechnic High School in San Francisco.

Milly completed one year at San Francisco State College studying to be a physical education teacher, dropping out when World War II started to serve her country. She was a "Ditto" (mimeograph) machine operator with the typewriter pool for U.S. Army Corps of Engineers, who sent supplies to the troops overseas. Further work experience included being a Pacific NW Bell switchboard operator and U.S. Post Office mail sorter. She wrote letters to over 30 service members during the war, including her future husband Clyde, who she met at a stadium while attending a high school football game with her older brother. Clyde began carrying her books every day while walking her home from school and he lived in another part of town.

After the war ended, Clyde proposed, she accepted, and they were married on June 30, 1946, at San Francisco. The couple moved to Sumpter Valley in 1951 and began operation of the Bow & Arrow Ranch.

Milly enjoyed the outdoor life of a rancher: fixing fences, haying, riding horses, wrangling cows, pulling calves, cooking for the ranch hands, etc. She loved animals, especially dogs. Her hobbies were painting, gardening, sewing, cooking, crafting, fishing, camping, playing piano and accordion, dancing, dining out, etc. Milly and Clyde were well known for square dancing with the Crazy 8s. Milly never met a person she couldn't call a friend, she was cheerful, friendly, outgoing, welcoming and on and on.

As an active member of a rural community, she was a 4-H Horse Club leader for the Silver Spurs for 13 years. She loved baking pies for church potlucks, Eastern Star Bingo, Powder River Rural Fire Department/Sumpter Valley Railroad and other fundraisers. She is a life member of Alpine Chapter, Order of Eastern Star.

Milly loved being a mother to two daughters; Elly (Ed) Styskel of Newport, Washington, and Marilyn (Pat) Sullivan of Colorado Springs/Aurora, Colorado, giving her 8 grandchildren, 15 great grandchildren, 5 great-great grandchildren, 5 nieces and many cousins. She was also surrogate mother to some of the hired ranch hands over the years.

Milly and Clyde are charter members of what is now McEwen Bible Fellowship dedicated to sharing their strong faith in the community.

Clinton H. "Clint" Bellows, 90, a former Halfway and Baker City resident, died July 4, 2018, at Las Cruces, New Mexico.

A memorial service will be held at a later time.

"We were all blessed by his musical talents and his gorgeous voice," his family said.

Clint was born on Sept. 11, 1927, to Harold and Hazel Bellows at Walla Walla, Washington. Clint grew up in Halfway, graduated from Baker High School and attended the University of Oregon and Capital University.

He enlisted in the U.S. Marine Corps at age 17 and was honorably discharged as a first lieutenant. He then joined the Oregon/Washington National Guard and served 26 years. Clint was also a patron member of the National Rifle Association. He was an active member of the Episcopal Church and Wellspring Church

Clint owned KYET radio in Payette, Idaho, which he sold when he became a news reporter and anchor on KTVB TV in Boise. He also served as mayor of Ontario. He had two daughters, Julie and Linda, with Nita Bellows.
