# Patrol seeking volunteers

Edie Richerson joined Citizens on Patrol before she even moved to Baker City.

"Before I got down here, I read on the city's page that they needed volunteers," she said.

That was in 2012 and she's been an active member ever since.

Citizens on Patrol (COP) is a non-paid volunteer program that works with the Baker City Police Department. The group is currently at five members, but is actively recruiting to grow their number to 10 or more.

"We need more people," Richerson said.

The COP work closely with Phoebe Wachtel and Chief Dustin Newman at the Baker City Police Department.

"They want us to have a presence in the community," Richerson said.

On Aug. 7, the Citizens on Patrol will be at Community Night Out in Geiser-Pollman Park to do child identification kits that record a child's thumbprint and a photo. These are not kept on file, but sent home with the parents and can be used in case of a kidnapping or missing child case.

The child ID station will be set up at the COP building located near the park restrooms.

### Variety of ways to help

Volunteers with COP can choose to assist in many ways, from foot patrols along the Leo Adler Memorial Parkway to assisting

with the annual Easter Egg Hunt.

Marlene Rogers, who is in her fifth year as a COP, joins Richerson to cover the police department's front desk when Wachtel is out of town.

All Citizens on Patrol are required to work in pairs.

"We always have to go in pairs for security reasons," Rogers said.

While patrolling, the Citizens on Patrol remind people of the city ordinances, such as no smoking in the parks and no skateboards on the sidewalks. They don't have authority to take action.

"Our job is to observe and call dispatch," Richerson said. "We're there to be a presence, but also to help people."

For instance, at a previous Easter egg hunt in the park, a member of COP helped reunite a parent and child.

Other jobs have included ringing bells for the Salvation Army during the holiday season, serving lunch at elementary schools, and helped Wachtel with car seat clinics and rabies clinics.

In 2013, the COP also helped survey community members who were affected by the cryptosporidium outbreak.

"As much as you want to do, or as little as you want to do," Wachtel said of the time commitment. "It's a great way to learn a little about law enforcement and help your community."

Requirements to be a Citizen on Patrol include:

- Valid Oregon state drivers license
- Must be a resident of Baker County
- Must pass a background check
- Must have good references

The first step is to submit an application, followed by an interview. Once selected, members will receive training in the duties and responsibilities of being a Citizen on Patrol.

### Blue-green algae warning for Brownlee

The Idaho Department of Environmental Quality on Wednesday issued a health advisory for Brownlee Reservoir due to a bloom of toxic blue-green algae, also known as cyanobacteria.

The advisory is for the reservoir from Spring Recreation Site, near Huntington, to Brownlee Dam.

Cyanobacteria blooms occur in waters with high levels of nutrients such as phosphorus and nitrogen. Recent tests indicate that toxins are present in Brownlee Reservoir, according to the Idaho DEQ.

The agency advises the following:

- Humans, pets, and livestock should not drink the reservoir water.
- Humans and animals should stay out of the reservoir. Swimming, wading, or other activities with full body contact of reservoir water should be avoided.
- Fish should be cleaned and rinsed with clean water. Only the fillet portion should be consumed.


