In the past, Ott said she used her own car to transport animals, and the miles were adding up.

"It's nothing for me to drive to Seattle and back in one day," she said.

Ott said Best Friends receives donations frequently, and the organization is sometimes listed as a suggested memorial donation in obituaries.

But the donation of a brand-new van is quite a different matter.

"(The donor) came to me and said, 'Carmen I want to do something for you,'" and I said, 'don't do something for me, do something for Best Friends,'" Ott said. "She said she'd buy us a new rig but it had to last for a long time."

Five drivers are insured to drive the vehicle, but Ott said she and her husband, Bill, probably will be behind the wheel most often.

Best Friends had used a Ford Explorer for the past 15 years, but Ott said she uses that vehicle for things around town like picking up food and smaller loads.

Now in its 36th year, Ott said it's amazing how the organization has grown.

"Thirty-six years ago, who would've thought we'd even own a van," she said.

Ott said she took the donor for a ride in the van after they purchased it and the donor loved it.

The organization used to have a 1970s van they referred to as the "Critter Get-

ter," and Ott is considering names for this new vehicle.

While she said they're always grateful for donations, it's not always checks that Best Friends needs.

"Monetary donations are

wonderful, but we desperately need foster homes," she said.

She said her family alone has fostered over 200 animals and the organization could save the most money

if it had more temporary homes for dogs and cats to avoid paying boarding fees.

Anne Kirkpatrick

Baker City, 1924-2018

Anne Lumsden Kirkpatrick, 94, of Baker City, died Aug. 24, 2018, at her home.

Her memorial service will be Friday, Sept. 7, at 2 p.m. at the First Presbyterian Church, 1995 Fourth St. Following the service, friends are invited to join the family for a reception in the church Fellowship Hall.

Anne was born on April 17, 1924, at Hollywood, California. She started school in the academy at Medford, moved to the Portland area and then settled in La Grande. Anne was very active at La Grande High School in music, journalism, Honor Society as well as becoming the first female student body vice president. She graduated from La

Grande High School in 1942 then furthered her education by earning a degree in dietetics and institution management from Oregon State University. Anne completed her dietetic internship at Charity Hospital in New Orleans. While at Oregon State University she was a member and president of Kappa Kappa Gamma sorority. She remained active in journalism as the manager of the Oregon State Daily Barometer newspaper.

After graduating from Oregon State, Anne worked at St. Elizabeth Hospital in Baker City until marrying Bruce Kirkpatrick on June 25, 1949. They continued to live in Baker City, where Bruce had the Chevrolet automobile business. She was an active homemaker in the '50s, '60s, and '70s, raising four children.

She returned to dietetics in the 1960s, commuting to Grande Ronde Hospital

in La Grande to work as clinical dietitian there until retiring in 1976.

Anne loved her family and her dear friends. She also loved to play bridge, travel and read. She was active in the First Presbyterian Church, PEO chapter AX, multiple bridge clubs, AAUW and was a dedicated board member of the DeWuhs Keckritz educational foundation scholarship board for 22 years. Anne was especially committed to helping young people with furthering their education.

Anne is survived by her daughter, Susan Lewis and her husband, Brent, of La Grande; her son, John Kirkpatrick of Clarkston, Washington; her daughters-in-law, Dana Kirkpatrick Kutsch (spouse Kim), and

Jeanie Kirkpatrick; seven grandchildren: Ruth, Nicole, Elizabeth, Cara, Ryan, Adam, and Kevin; and nine great-grandchildren.

She was preceded in death by her husband, Bruce; a daughter, Kathy Ann; a son, Bill Kirkpatrick; and her brother, Treve Lumsden.
