Baker City councilors tabled their discussion Tuesday about whether to accept a \$426,000 federal grant to hire three firefighter/paramedics for three years.

The City has until Nov. 1 to decide on the grant after City Manager Fred Warner Jr. received a one-month extension from the Federal Emergency Management Agency (FEMA), which administers the grant.

If the City Council accepts the grant, the city would have to raise about \$265,000 as a match. The amounts would be smaller the first two years.

During those years, Warner told councilors, the fire department's savings in overtime costs due to the three new employees would cover the grant match.

BTI heavy equipment course starting

Baker Technical Institute will be offering a threemonth-long "Heavy Equipment Operator Training — Comprehensive Course" beginning Sept. 17.

Classes will meet from 5 p.m. to 9 p.m. Mondays, Tuesdays and Wednesdays through Dec. 19. The cost is \$4,500.

BTI is located in the northwest wing of Baker High School at 2500 E St. The entrance is on the back side

of the building off Ninth and G streets.

A couple of openings still remain in the class, Tammy Pierce, BTI program coordinator, stated in an email to the Herald.

In addition to the handson training, students benefit from a low student/teacher ratio and will learn career readiness skills including job searching, interviewing and resume building through the Future Center at Baker High

School, Pierce said.

To register, go to bakerti. org/technical-training/ and click on Heavy Equipment Operator School or call Pierce at 541-524-2651 for more information.

The 220 hours of training is designed for beginning to experienced heavy equipment operators who want to enroll in a comprehensive training course on graders, dozers, excavators and wheel loaders, a press release announcing the course stated.

Experience hours on the equipment will take place at BTI's land lab or at job sites that are working with the BTI instructors to refine what students have learned on the simulators.

Upon completion of the course, operators will receive a certificate that shows their proficiency through a five-level scale ranging from beginner to master.

City Manager Fred Warner Jr. said the Rienkses' complaint influenced his decision to have councilors on Tuesday approve the minutes from 10 previous meetings.

Those meeting dates are: Jan. 9, Feb. 27, March 6, April 3, May 9, June 26, July 10, July 24, Aug. 14 and Aug. 28.

Smith said that in the future the minutes will be ready for approval by the

next meeting, unless there are extenuating circumstances such as her missing work due to illness.

Although councilors had not approved the minutes from those 10 meetings, draft versions of the minutes were available, on request, at City Hall soon after each meeting, Warner said.

The draft minutes were not posted on the city's website, however.

To catch up on the minutes from the 10 meetings, Smith said she devoted Sept. 5-7 to

proofing those, then came in over the weekend to work on HR duties.

Oregon's public meetings law doesn't specify how frequently minutes must be approved by a city council, although the law states that minutes must be available to the public "within a reasonable time after the meeting."

In other business Tuesday, the Council voted to have an Economic Opportunity Analysis done for the city.

The analysis will be funded from a state grant and won't require the city to provide matching funds or manage any money. The grant was accepted by the Baker County commissioners last week which enabled cities in the county to decide to opt into the program.

Councilors also appointed Molly Wilson to the final open position on the Public Arts Commission. Wilson will serve until April 2021.

Councilors also passed a resolution expressing support for America's national parks.

Continued from Page 1A Risk said that day after he received his permit, a third company, A-1, was approved to also operate within the city limits, joining Elkhorn Cab

and Baker Cab Co. Warner says that he never told Risk that the city has a limit on the number of taxi companies.

A 1992 city ordinance allows one taxi vehicle per 1,500 residents, but it does not limit the number of separate businesses. Each taxi company has to receive a separate permit, including the number of vehicles it plans to use, which is how the city enforces the limit on the number of taxi cabs.

That ordinance hasn't been changed recently, Warner said. Risk also contends that

he was the victim of what he calls a "sting" operation that resulted in a \$500 fine.

Risk had been approved by Warner and the Baker City Police Department to provide free rides to citizens in May. At

the time there was only one other cab company operating in town. Risk says these rides were

free, but Police Chief Dustin Newman said his department received "numerous complaints" from citizens about Risk demanding money from passengers.

The Police Department then assigned an officer, who wasn't in uniform, to request a ride as a compliance check. After Risk requested a donation, the city issued him a \$500 fine, the base amount for city ordinance violations.

Risk says he argued the citation in court. He said it was dismissed but then reissued the next day.

Since then the city and police haven't had any issue with Risk.

Elkhorn Cab is a company run on faith, Risk said.

He said he has lost much of his savings from running the company.

"There is plenty of business to go around," said Warner about the taxi industry in Baker City.
