Sparta man dies in 4-wheeler crash

A Sparta man died in a four-wheeler acci-

dent Friday morning while herding cattle. Sheriff Travis Ash said Burleigh Allen, 71, of 29004 Sparta Lane, died at the scene about 25 miles northeast of Baker City.

The crash happened about 10 a.m. Friday. Ash said it is unknown whether driver error or a medical event caused the crash.

Allen had been traveling across private property at the top of a knoll when he was thrown over the front handle bars of the four-wheeler. The vehicle rolled over his body and continued to roll to the bottom of a canyon, Ash said.

"It was a tragic accident," he said. Ash and Deputy Craig Rilee were dispatched to the scene. The Keating Quick Response Unit and a Baker City ambulance crew also responded.

The Baker School District has mailed a flier to residents that explains how it would spend the money if voters approve the bond.

The district paid \$526 for postage.

The biggest projects proposed are:

- Building a new school for students in grades 1-6 on property the district bought last year north of the Baker Sports Complex and south of Hughes Lane — \$37 million
- Remodeling parts of Baker High School to accommodate seventh- and eighthgrade students in a separate space — \$10 million
- Remodeling Brooklyn Elementary as an Early Learning Center, which would include kindergarten students — \$4 million
- Improvements to Haines and Keating schools — \$1

million

The district has secured a \$4 million grant from the state that would be available if voters approve the measure.

Although the state law prohibits public employees from advocating for bond measures and other political issues while at work, the law does not forbid public employees from making financial contributions to political committees, said Debra Royal, a spokeswoman for the Oregon Elections Division.

Baker School Superintendent Mark Witty is one of the two largest contributors to the Yes for Kids Committee, with two donations totaling

Melanie B. Kemper also contributed \$1,000.

Betty Palmer, the district's assistant superintendent, contributed \$500.

Three of the five members of the Baker School Board

also made contributions — Katie Lamb, Julie Huntington and Kevin Cassidy.

Like school district employees, board members can contribute money to political campaigns.

Unlike public employees, board members, because they are elected officials, are not affected by the law regarding public employees and advocacy.
