Freeway crash sends sailboat into the sage

A 27-foot sailboat was launched into a sea of sagebrush Monday afternoon in a crash in the westbound lanes of Interstate 84 just north of Huntington.

The sailboat was being transported on a trailer towed by a Lincoln Navigator driven by Brent E. Johnston, 62, of Nampa, Idaho. The incident began when a tire came off the trailer at about 4:40 p.m., according to an Oregon State Police report.

A second vehicle, a Chevrolet van driven by Blanca R. Calderonvega, 40, of Boise, veered to avoid the tire as she was passing Johnston. The van struck the median and then the boat trailer, causing Johnston to lose control of his vehicle.

Police said the boat trailer became unhitched from the Navigator, which struck the center barrier and came to rest on the right shoulder.

The van, which was heavily damaged, came to rest across both lanes of travel. The sailboat became dislodged from the trailer after striking the guardrail and traveled down an embankment before coming to rest in a field about 60 feet off the roadway.

There were no injuries and no citations were issued, police said.

A second Monday crash happened at 10:34 p.m. Monday on Highway 7 near Baker City when a driver tried to remove a dead deer from the road.

OSP said while the driver who struck the deer was attempting to removed the animal, a southbound Subaru Forester driven by Darryl C. John, 66, of Caldwell, Idaho, veered in an attempt to avoid running over the deer. His vehicle left the highway via the right shoulder and as he overcorrected, it traveled across both traffic lanes, rolled down an embankment and came to rest on its side

There were no injuries to either driver involved, police said.
