School bond PAC gets \$5K donation

A \$5,000 check from a group associated with the Oregon School Employees Association has nearly doubled the fundraising total for the political action committee supporting the Baker School District's \$48 million construction bond measure.

The Yes for Kids Committee received the \$5,000 cash contribution from School Employees Exercising Democracy on Sept. 26.

The committee has collected \$10,543 in cash since forming on Aug. 8.

School Employees Exercising Democracy is based in Salem at the state office of the Oregon School Employees Association, a labor union with 20,000 members.

School Employees Exercising Democracy was formed to support school district bond measures, according to records it filed with the Oregon Elections Division.

The organization has received \$125,000 in cash contributions this year — all from the Oregon School Employees Association — and has spent

The group has contributed cash to several measures this vear in addition to Baker School District's Measure 1-88, which district voters will decide on Nov. 6.

Measure 1-88, which would boost property taxes by an estimated \$1.97 per \$1,000 of assessed property value for the next 30 years, would make possible:

• Building a new school for students in grades 1-6 on property the district bought last vear north of the Baker Sports Complex and south of Hughes

Lane — \$37 million

- Remodeling parts of Baker High School to accommodate seventh- and eighthgrade students in a separate space — \$10 million
- Remodeling Brooklyn Elementary as an Early Learning Center, which would include kindergarten students — \$4 million
- Improvements to Haines and Keating schools — \$1 million

The district has secured a \$4 million grant from the state that would be available if voters approve the measure.

Fire Prevention Week poster contest

Recognition of National Fire Prevention Week begins Sunday and will continue through Oct. 13.

During the week, the Baker County Interagency Fire Prevention Team, consisting of federal, state and local fire agencies serving Baker County, is asking schools and families to participate in a poster contest.

This year's contest is centered around the theme of "Look, Listen. Learn — Be Aware. Fire can happen anywhere." said Gary Timm, fire division manager for Baker County Emergency Management.

The campaign is aimed at providing a reminder that when a fire breaks out in a home seconds count, Timm said. Those seconds can make a difference between life and a tragedy.

This year's theme identifies basic ways people can reduce their risk of fire and to be prepared in the event one does happen. This advice is offered by the Baker County Interagency Fire Prevention Team:

• Look for places fire can start. Take a good look around your home. Identify potential

fire hazards and take care of them.

• Listen for the sound of the smoke alarm. You could have only minutes to escape safely once the smoke alarm sounds. Go to your outside meeting place, which should be a safe distance from the home and where everyone should know to meet.

• Learn two ways out of each room in the house and make sure all doors and windows leading outside open easily and are free of clutter.

Fire agencies across Baker County will be working with schools and students in

Grades 4-6 to develop fire prevention posters promoting National Fire Prevention Week, Timm said.

Posters will be collected from all Baker County schools and North Powder on Monday, Oct. 8. One winner from each class will be announced during the week. They will be offered a ride in a fire engine during the Baker City Christmas Parade, Timm said.
